**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, AMENDING SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 86, SOLID WASTE, ARTICLE II, GARBAGE AND ARTICLE IV, CURBSIDE RECYCLING; PROVIDING A SEVERABILITY CLAUSE, AN EFFECTIVE DATE, PROVIDING FOR PUBLICATION, AND DIRECTING STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES**

**WHEREAS**, the City of Seguin has received a request from Progressive Waste Solutions to decrease the collection rates for solid waste and recycling services based on a decreased in fuel costs; and

**WHEREAS**, the City Council agrees that the requested decrease is appropriate, making it necessary to amend Appendix C – Fee Schedule for these services at the revised rates listed below.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Seguin, Texas:

**SECTION ONE**, The Seguin Code of Ordinances, Appendix C – Fee Schedule, Chapter 86, Solid Waste, Article II, Garbage is amended as follows (underlining indicates added text, ~~strikethrough~~ indicates deleted text):

Article II - Garbage

(a) Monthly charge for residential garbage and trash collection

(1) One time per week ~~\$12.57~~ \$12.25

**SECTION TWO**. The Seguin Code of Ordinances, Appendix C – Fee Schedule, Chapter 86, Solid Waste, Article IV, Curbside Recycling is amended as follows (underlining indicates added text, ~~strikethrough~~ indicates deleted text):

(a) Monthly charge for residential customers one time per week.....~~\$3.03~~ \$3.00

**SECTION THREE**. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

**SECTION FOUR**. City Staff is hereby authorized to publish this ordinance in a newspaper of general circulation and submit this Ordinance as a supplement to the Seguin Code of Ordinances.

**SECTION FIVE**. Rate decrease has an effective date of April 1, 2015.

**Passed and approved** the second reading on the 21<sup>st</sup> day of April, 2015.
