Equipment Purchase – 2024 Carlson CP130 Paver

The Public Works 5-Year Capital Equipment plan recommends the purchase of a new paver. The new paver will replace a 2016 Mauldin Paver. The laydown machine is 8 years old and is the only asphalt laydown machine the city owns. Crews are placing an average of over 11,000 tons of hot mix a year. This machine has been in for many repairs. When it is out for repairs, staff either must wait for repairs to be completed or rent another to continue paving operations. With the amount of work accomplished with this machine it is at the end most effective.

Staff has received a quote from Cooper Equipment Co., San Antonio, Texas in the amount of \$328,615.40 plus \$\$6,486.15 for 3-year Edge Warranty for a total of \$335,101.55 utilizing BuyBoard. BuyBoard is a government unit established with the purpose of simplifying purchasing power to obtain better pricing. Staff finds the new equipment purchase and warranty to be the most cost effective and within the estimated budget of the 5-year plan.

Staff recommends purchase approval of the 2024 Carlson CP130 Paver plus the extended Edge Warranty in the amount of \$335,101.55. Funding will come from the mid-year budget amendments as presented for second reading by Finance at the meeting.
