Biggest Small-Town Fourth of July Parade COVID Contingency Plan

Instead of you going to the parade, the parade is coming to you.

Due to the COVID-19 pandemic and the ban on public gatherings of ten or more people, Seguin Main Street is developing a contingency plan that will allow the City of Seguin to continue to host the Biggest Small-Town Fourth of July Parade, an annual tradition going back decades.

Parade Floats and Entries

- No parade entry can have more than ten people on a float
- No walking or marching entries
- No eighteen wheelers
- Trailers shall not be longer than 16 feet.
- Encouraging families to decorate their own personal vehicles and be a parade entry
- Entries should arrive with their vehicle/float already decorated entries will not be allowed to decorate their vehicle in the parade staging area other than small last-minute additions
- Entries would still have to provide a release of liability
- All parade entries will have their flashers on while driving the route

Rules and Locations for Spectators

- Spectators should be on their own front porch or lawn along the revised parade route
- Spectators in mass viewing areas shall remain in their vehicles. Would ask PD or FD to assist in patrolling these areas to enforce this rule.

Parade Staging

- As they arrive entries would line up in the Events Complex Center parking lot to the west of the rodeo arena in rows similar to the food distribution.
- VIP entries, including elected officials, grand marshal and military entries, will line up in the Events Complex parking lot outside the dance slab.
- One lane reserved for fire department vehicles

Department Assistance Needed

Public Works:

- Barricades and cones at parade staging.
- Street sweeper to sweep parking lots of mass viewing areas

Police Department:

- Assist with traffic control

Fire Department

- Assist in closing intersections and enforcing viewing rules
- Have a truck in the parade route

Parks Department

- Assist in monitoring and cleaning parks
- Open and close restrooms in parks/coliseum

- Order portable toilets for placement at mass viewing areas
- Collect liability waivers
- Organize line up
