Presentation and update on the project status of Rudeloff Road Phase I construction. - Melissa Reynolds, P.E., CFM, MPA - Director Capital Projects | Engineering

# Indexes:

Director of Capital Projects and Engineering Melissa Reynolds gave an update on the status of the Rudeloff Project. She informed that construction started this summer and the utility work is 70% complete and the road is approximately 7% complete, consisting mostly of ROW clearing. She explained that the current focus is Culvert #3 and the waterline. Roadway construction is scheduled to begin first quarter of next year. While there is still a conflict with AT&T, the project is still moving forward, with an estimated completion early 2026. She stated that potholes are being patched in areas of wash out but that the contractor is required to keep the road drivable and maintain it up to the condition it was in when the project began.

Councilmember Carlsson thanked Mrs. Reynolds for her responsiveness to his questions and concerns related to this project. He commented that pothole maintenance does make things a little better and that any progress reports on this project are appreciated.

Councilmember Lievens thanked Mrs. Reynolds for her presentation and declared that he does not give her enough credit. She has won many awards in her field and things have really moved forward at a much faster pace since she has been employed with the City. Councilmember Lievens asked Mrs. Reynolds when she thought the two new lanes will be open and Mrs. Reynolds replied in about six months, but depends on

weather as well as if there are any change orders. Because this is a federally funded project, any change orders must not only be approved by the City, but AAMPO, TxDot and the Federal Government

Councilmember Carlsson commented that because there is no center strip on the road it is difficult to navigate at night. Deputy City Manager Rick Cortes said that the City can look at striping the road, but that it require spending tax payer money on a temporary solution.

Resolution of the City Council of the City of Seguin, Texas awarding a bid in the amount of \$17,911,808.79 to D&D Contractors, Inc. for the North Heideke Street Drainage Improvement Project (a GLO CGBG-MIT Grant Project); authorizing the City Manager to enter into a construction contract with D&D Contractors, Inc.; and declaring an effective date. - Melissa Reynolds, PE, MPA, CFM, Director Capital Projects | Engineering

Director of Engineering and Capital Projects Melissa Reynolds reminded that the City of Seguin was awarded a grant for nearly \$38M from the General Land Office for flood mitigation and infrastructure improvements. The City has divided the work into four projects and the largest of the 4 projects is the North Heideke project. The request for bid consisted of a base bid and bid alternate. The City received 6 sealed bids. The base bid amounts ranged from \$15.5M to \$24M. The bid alternate amounts ranged \$17.9M to \$22.6M. TRC is the engineer of record for this project. After completing the bid tab analysis, the recommendation was to go with the bid alternate because the October 2026 deadline for completion is critical to ensure grant funding. The apparent low bidder for the alternate bid, D&D Contractors, Inc. has successfully completed similar work in the past. Additionally, they are nearing completion on a complex street reconstruction project with the City of Seguin and they have performed well on that project. The engineer of record, TRC, conducted reference checks on other projects supplied and found they have successfully completed those projects. Mrs. Reynolds recommended that the project be awarded to the low bidder for the Alternate Bid, D&D Contractors, Inc. in the amount of \$17,911,808.79.

Joe Olivares, 211 W. Jefferson Ave., Harlingen, informed that he represents GO Underground LLC, the apparent low bidder on the base bid. He explained that his bid was for nearly \$2.3M less than was awarded. He said he had checked with local suppliers who guaranteed that box culverts had a lead time of only 2-3 weeks. He said he has been in this business for 24 years and is bonded up to \$60M. He said that he has had very little communication with the engineer on this project and would have liked the opportunity to explain his means and methods. He asked City Council to consider tabling this item and revisiting it at a future meeting.

Councilmember Gaytan asked Mrs. Reynolds for her response to Mr. Olivares. Mrs. Reynolds answered that TRC and City Staff did a diligent review of references and bid items and that their recommendation stands. She said that there were a lot of factors that played into the decision, like the discrepancy in bid, limited references and experience with a project of this size, the location and accessibility of the street, and large scale new developments and the timeline and critical nature of the project.

Deputy City Manager Rick Cortes commented that knowing the contractor and the quality of the work they do makes a difference on a project of this size. He added that he is confident in the recommendation made.

City Attorney Mark Kennedy explained that Darrell Dunnig executed a contract for municipal judicial services with the City of Seguin in 2023, the term of which ran until December 6, 2024. His appointment has remained that of an "Associate Judge", even though he is the lone judge presiding over municipal matters, after Judge Kevin Kolb passed away on March 28, 2023. Staff would like an opportunity to properly procure a contract for Judicial Services, resulting in an appointment to the Municipal Judge position by City Council in accordance with City Ordinance. Extending Judge Dullnig's contract through the first quarter of 2025 will provide staff

the opportunity to develop specifications and bring an item back to City Council to identify and

implement the process for procuring such services. Since Judge Dullnig's contract expired on

December 6, 2024, an extension is appropriate under the circumstances. If the contract extension is approved, Judge Dullnig will hold over in his appointment until end of the contract term, March 30, 2025.
