

CITY OF SEGUIN

AN ORDINANCE AMENDING THE SEGUIN CODE OF ORDINANCES CHAPTER 98, TRAFFIC AND VEHICLES, ARTICLE V, STOPPING, STANDING, AND PARKING, SECTION 98-107, NO PARKING ZONES, TO ESTABLISH A NO PARKING ZONE ON THE EAST SIDE OF HUBER ROAD, PART OF THE NORTH SIDE OF RUDELOFF ROAD, AND BOTH SIDES OF THE ROAD AT THE CURVE AT THE NORTHEAST SIDE OF THE FIELDS OF HUBER RANCH; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR PUBLICATION; PROVIDING PENALTIES FOR VIOLATION THEREOF; AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES

WHEREAS, the City has received numerous complaints regarding the excess parking along Huber Road during softball events; and

WHEREAS, parts Huber Road have a limited sight distance and parking narrows the road to one lane passage creating a potentially dangerous situation; and

WHEREAS, it is in the best interest of the residents and visitors of the City to maintain safe passage on the City's roads; and

WHEREAS, after studying the road, including when heavy parking is taking place, the City engineer recommends that parking be limited.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Seguin, Texas, as follows:

SECTION 1. The Seguin Code of Ordinances, Chapter 98, Traffic and Vehicles, Article V, Stopping, Standing and Parking, Section 98-107, No Parking Zones is amended (underline indicates added text, ~~strikethrough~~ indicates deleted text) as follows:

The following areas are designated no parking zones:

- (1) Convent Street from South Austin Street to South Milam Street.
 - (2) Shelby Street from Walnut Branch to South Milam Street.
 - (3) From the intersection of Huber and Rudeloff Road on the east side of Huber Road travelling 850 feet south.
 - (4) Along the north side of Rudeloff Road between the two legs of Huber Road.
 - (5) Both sides of the curve located at the northeast corner of the Fields of Huber Ranch.
- (b) City staff is hereby directed to erect no parking signs in the appropriate blocks in accordance with this section.
- (c) Violations of this section shall be punished in accordance with the penalty provisions of the City of Seguin Code of Ordinances.

SECTION 2. Where allowed all cars parking along Huber and Rudeloff Roads in the vicinity of the Fields of Huber Ranch shall park in such a manner that the vehicle is no less than five feet off the paved surface.

SECTION 3. City staff is hereby directed to erect no parking signs along Huber Road and Rudeloff Road in accordance with this ordinance.

SECTION 4. Violations of this Ordinance shall be punished in accordance with the penalty provisions of the City of Seguin Code of Ordinances.

SECTION 5. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.

SECTION 6. In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following passage on second reading and shall be published in a newspaper of general circulation.

SECTION 7. City staff is authorized to prepare this Ordinance for submission as a supplement to the Seguin Code of Ordinances.
