A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AWARDING A BID TO M&C FONSECA CONSTRUCTION CO. INC. FOR THE CONSTRUCTION OF THE FM 20 / HANNAH HEIGHTS WATER LINE TO INCLUDE VARIOUS APPURTENANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH M&C FONSECA CONSTRUCTION CO. INC.; AND DECLARING AN EFFECTIVE DATE

WHEREAS, City Council previously approved an engineering services proposal for the design, bidding, and construction administration services for the FM 20 / Hannah Heights Water Line; and

WHEREAS, the above referenced project is to install approximately 4,000 linear feet of 12" PVC water main with all other necessary appurtenances; and

WHEREAS, the above referenced project was prescribed as part of the 2022 Water Master Plan; and

WHEREAS, this project will improve service to the existing developments as well as provide adequate capacity for the parcels immediately south and east; and

WHEREAS, the City solicited bids for the construction of the FM 20 / Hannah Heights Water Line to include various appurtenances; and

WHEREAS, seven bids were received ranging from a low bid of \$908,389.10 to a high bid of \$1,716,601.85; and

WHEREAS, reference checks on projects supplied by the bidding contractors found that M&C Fonseca Construction Co. Inc. has completed projects to the satisfaction of the Owners and Engineers.

WHEREAS, based on the reference checks, City staff recommends accepting the low bid of \$908,389.10 submitted by M&C Fonseca Construction Co. Inc. plus \$91,610.90 in contingency for a total amount of \$1,000,000.00; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin, Texas:

Part 1. The City Council of Seguin, Texas, hereby approves the bid submitted by M&C Fonseca Construction Co. Inc. in the amount of \$908,389.10 for the construction of the FM 20 / Hannah Heights Water Line to include various appurtenances, plus \$91,610.90 in contingency for a total amount of \$1,000,000.00.

Part 2. The City Manager is authorized to enter into an agreement with M&C Fonseca Construction Co. Inc., for the construction of the FM 20 Hannah Heights Water Line to include various appurtenances.

Part 3. This Resolution is effective from and after the date of its passing.
