**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS,
CANVASSING RETURNS AND DECLARING RESULTS OF THE GENERAL
ELECTION HELD ON NOVEMBER 5, 2024, FOR THE PURPOSE OF
ELECTING A MAYOR AND CITY COUNCIL MEMBERS FOR DISTRICTS
ONE, TWO, FOUR, AND SIX; AND DECLARING AN EFFECTIVE DATE.**

WHEREAS, on August 6, 2024 the City Council ordered that a General Election be held on November 5, 2024, for the purpose of electing a Mayor and a City Council Member District 1; a City Council Member District 2; a City Council Member District 4; and a City Council Member District 6; and

WHEREAS, notice of the general election was duly published in the Seguin Gazette on October 20, 2024; and

WHEREAS, the Affidavit of Posting Notice for the general election was posted on the bulletin board at City Hall on August 13, 2024; and

WHEREAS, the general election was duly and legally held on November 5, 2024, in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the proper judges and clerks; and

WHEREAS, the City Council of the City of Seguin, Texas with the following members present: Mayor Donna Dodgen, Joe Rea, Jim Lievens, Chris Rangel, Paul Gaytan, Monica Carter, Jason Biesenbach and Bill Keller have today considered the returns of the General election held on November 5, 2024; and

WHEREAS, it appears to the Council, and the Council finds, that the election was in all respects lawfully held; and

WHEREAS, it appears to the Council, and Council finds, that the tabulation of the results of the election is correct.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin:

SECTION 1. The General Election of November 5, 2024, was duly called, notice of the election was given in accordance with law, and the election was held in accordance with law.

SECTION 2. The tabulation of votes cast in the General Election held on November 5, 2024, for the purposes stated in Recital 1 above, a copy of which is attached to and made a part of this Resolution is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the City of Seguin as the official canvass of the election.
