He had spoken with the job foreman and was assured the sign would be installed when complete. City Manager Steve Parker said staff would follow-up with TxDOT and advise him.

Mr. Leal spoke about the terrible things going on in the United States on racial issues. The issues have been going on since Eisenhower was in office. Changes are needed.

Council Member Jeremy Roy - Recognized Rev. Arthur Malone Jr. and Rev. Jimmy Flakes for their dedication and hard work to break barriers within our community. Councilman Roy said he was taking a stand against racism and encouraged our community to do more. He spoke of the prayer service that was held at Central Park on Monday, June 1st and recognized Chief Nichols and all Seguin police officers for their willingness to be a part of the uplifting prayer to George Floyd family. Councilman Roy said he felt those in attendance had an opportunity to visit with the officers and to hear that this type of violence would not be tolerated in Seguin.

Estimated price tag of \$184 million in new debt over thirty years
Significant new account growth - new rate and impact fee revenues

Ordinance on first reading amending the Seguin Code of Ordinances, Chapter 14, Animals, Article IV, Livestock, to change the rules related to keeping fowl; providing for an effective date; providing for a severability clause; providing for publication; and authorizing City Staff to prepare this ordinance for submission as a supplement to the Code of Ordinances - Shelly Lutz, Animal Services Manager

Shelly Lutz, Animal Services Manager, said based on research from citizens and surrounding cities staff is recommending the following changes to the ordinance:

- 1. No more than 6 fowl (decrease from 12 in current ordinance) in an area less than 50 feet from a neighboring residence (decreased from 100 feet)
- 2. No roosters allowed in the city
- 3. Pens and fowl must be in a fenced rear yard
- 4. Pens and enclosures must be constructed to prevent rodents, rats, and mice from being harbored underneath the pen or enclosure yard

Sergio Guardiola 619 Stratton St Seguin, Texas

Mr. Guardiola presented a handout of his research and his suggested changes to the current city ordinance. He spoke on 1) having coops in the rear of the yard; 2) Coop requirements; 3) fence requirements; 4) square footage requirements; 5) 50-foot setback; 6) restricting the permissible quantity of chickens to six; 7)roosters; 8) Cleaning of pens; 9) 4H and FFA Exception; and 10) Local Ag Extension office.

The City Council members discussed the proposed changes to the ordinance and provided staff with additional changes. It was suggested that this item be postponed.
