**AN ORDINANCE OF THE SEGUIN CITY COUNCIL AMENDING THE SEGUIN CODE OF ORDINANCES, CHAPTER 98, TRAFFIC AND VEHICLES, ARTICLE II, TRAFFIC CONTROL DEVICES, SECTION 98-40, DESIGNATION OF NO THROUGH TRUCK TRAFFIC STREETS, BY ADDING CORAL SKY AND SADDLEHORN DRIVE AS AN ADDITIONAL NO THROUGH TRUCK TRAFFIC STREET; PROVIDING FOR PENALTIES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR PUBLICATION OF THIS ORDINANCE; AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE CODE OF ORDINANCES**

**WHEREAS**, the City Council has determined that installation of traffic control devices is necessary in order to protect the health, safety, and welfare of the citizens; and

**WHEREAS**, pursuant to Texas Local Government Code Section 51.001, the City has general authority to adopt an ordinance or police regulation that is for the good of the government, peace or order of the City and is necessary or proper for carrying out a power granted by law to the City; and

**WHEREAS**, commercial truck traffic has increased on certain streets in a manner that the increased traffic creates unsafe conditions; and

**WHEREAS**, the City Council desires to continue to provide safe use of City streets for vehicles and pedestrians.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Seguin:

**Part 1.** Section 98-40 (b) of the Seguin City Code is amended as follows (underlining indicates added text, ~~strike through~~ indicates deleted text):

(b) The following streets are designated as “no through truck traffic” streets:

Martindale Street from Guadalupe Street to Heideke Street.

Roosevelt Drive from North Austin Street to Heideke Street.

Rosemary Drive from North Austin Street to Heideke Street.

Patton Drive from North Austin Street to Heideke Street.

Crocket Street from Mountain Street to Walnut Street.

Walnut Street from Milam Street to River Street.

East Walnut Street from State Highway 123 Bypass eastward to the Seguin City Limits.

Preston Road from Highway 90A to Eastwood Drive (County Road 466).

Quintana Road from FM 464 to Interstate Highway 10.

Guadalupe Street from IH-10 to Highway 123 Business.

New Braunfels Street from Highway 123 Business (N. Austin St.) to Eighth Street.

City streets in areas designated by the unified development code as a residential district.

Meadow Lake Drive from Highway 123 Business to Highway 123 Bypass.

Huber Road from the eastbound IH-10 Frontage Road to New Braunfels Street.

Strempel Street from Highway 123 to Old Martindale Road.

Old Martindale Road from Highway 123 to East Martindale Road.

East Martindale Road from Old Martindale Road to Highway 20.

Hidalgo Street from FM 78 (W New Braunfels Street) to US 90 (W Kingsbury Street).

East Pine Street from North Ausin Street to North King Street.

Coral Sky from State Highway 46 to Rudeloff Road.

Saddlehorn Drive from Coral Sky to Coral Sky.

**Part 2.** The City's Director of Public Works is hereby authorized to designate Coral Sky and Saddlehorn Drive as no through truck traffic streets in accordance with this Ordinance and is further directed to erect appropriate signs or other markings giving notice thereof.

**Part 3.** Violations of this Ordinance shall be punished in accordance with the penalty provisions of the City of Seguin Code of Ordinances.

**Part 4.** In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following passage on second reading and shall be published in a newspaper of general circulation.

**Part 5.** If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.
