

STATE OF TEXAS

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 74, PARKS AND RECREATION, SECTION A – MAX STARCKE PARK GOLF COURSE; PROVIDING FOR A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE, AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES.

WHEREAS, in order to offset expenses, create a fund for golf course improvements and to remain competitive with other area golf courses staff is recommending changes to the golf course fee structure; and

WHEREAS, the changes will include a phasing out of annual memberships by not adding any new annual memberships; and

WHEREAS, existing annual membership holders, both resident and non-resident, can continue to renew their memberships as long as there are no gaps in said membership.

NOW THEREFORE BE IT ORDAINED by the City Council of Seguin, Texas:

Section 1. Appendix C – Fee Schedule, Chapter 74, Parks and Recreation, Streets and other Facilities, of the Seguin Code of Ordinances the City of Seguin, Texas is hereby amended as follows (underlining indicates added text, ~~striketrough~~ indicates deleted text):

(10) Trained and authorized golf course marshals are provided unlimited golf Monday through Friday with a cart at no charge for services provided.

Section 2. In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following passage on second reading.

Section 3. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

Section 4. City Staff is hereby authorized to submit this Ordinance as a supplement to the Seguin Code of Ordinances.
