**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AWARDED A BID TO M&C FONSECA CONSTRUCTION CO. INC. FOR THE CONSTRUCTION OF THE IH-10 & FM 464 WATERLINE EXTENSION TO INCLUDE VARIOUS APPURTENANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH M&C FONSECA CONSTRUCTION CO. INC.; AND DECLARING AN EFFECTIVE DATE**

**WHEREAS**, the SEDC Board previously approved an engineering services proposal for the design, bidding, and construction administration services for the IH-10 & FM 464 Waterline Extension; and

**WHEREAS**, the above referenced project is to install approximately 6,500 linear feet of 16" PVC water main, 180 linear feet of 8" PVC water main, 4,400 linear feet of 4" PVC fiber conduit with all other necessary appurtenances; and

**WHEREAS**, the above referenced project will support water demand from new or expanded business enterprises; and

**WHEREAS**, the City solicited bids for the construction of the IH-10 & FM 464 Waterline Extension to include various appurtenances; and

**WHEREAS**, six bids were received ranging from a low bid of \$2,270,412.00 to a high bid of \$3,516,595.00; and

**WHEREAS**, reference checks on projects supplied by the bidding contractors found the low bidder, M&C Fonseca Construction Co. Inc. has completed projects to the satisfaction of the Owners and Engineers.

**WHEREAS**, based on the reference checks, City staff recommends accepting the low bid of \$2,270,412.00 submitted by M&C Fonseca Construction Co. Inc. plus \$229,588.00 in contingency for a total amount of \$2,500,000.00; and

**NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin, Texas:**

**Part 1.** The City Council of Seguin, Texas, hereby accepts the bid submitted by M&C Fonseca Construction Co. Inc. in the amount of \$2,270,412.00 for the construction of the IH-10 & FM 464 Waterline Extension to include various appurtenances, plus \$229,588.00 in contingency for a total amount of \$2,500,000.00.

**Part 2.** The City Manager is authorized to enter into an agreement with M&C Fonseca Construction Co. Inc., for the construction of the IH-10 & FM 464 Waterline Extension to include various appurtenances.

**Part 3.** This Resolution is effective from and after the date of its passing.
