## **COUNTY OF GUADALUPE**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, ANNEXING INTO THE CITY OF SEGUIN A TRACT OF LAND CONTAINING APPROXIMATELY 64.34 ACRES, LOCATED SOUTH OF ALTERNATE 90; MORE FULLY DESCRIBED AS PROPERTY IDS 59056, AND 59057, LOCATED IN ABSTRACT 35, JOHN SOWELL SURVEY, AS SHOWN IN THE ATTACHED EXHIBITS, GUADALUPE COUNTY, TEXAS (VAN 05-03-2020\_01)

**WHEREAS,** the tract of land described as approximately 64.34 acres located in Abstract 35, John Sowell Survey, identified as Property IDs 59056, and 59057 and more fully described in the attached Exhibits A & B, lies entirely within the extraterritorial jurisdiction of the City of Seguin, Texas and is contiguous to the existing city limits; and

**WHEREAS,** the property owner of said tract of land has filed a petition with the City of Seguin requesting annexation into the Seguin City Limits as allowed in accordance with Section 43.0671 of the Local Government Code; and

**WHEREAS,** in accordance with Section 43.0672 of the Local Government Code, a written agreement for the provision of services has been prepared and agreed upon by the City of Seguin and the owner of the area proposed for annexation (Exhibit C) and is effective with the adoption of this ordinance; and

**WHEREAS,** the City Council of the City of Seguin, Texas finds it in the best interests of future development for this area, at the request of the property owner, that the area be annexed into the City Limits of the City of Seguin, Texas.

## THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin, Texas:

**SECTION ONE:** The City Council hereby finds that factual statements in the above recitals are true and hereby adopts said recitals as part of this Ordinance.

**SECTION TWO.** The tract of land totaling approximately 64.34 acres, situated in Abstract 35, John Sowell Survey, identified as Property IDs 59056 and 59057, more fully described in the attached exhibits, is hereby annexed into the City of Seguin, Texas, and from passage of this ordinance shall be said part of the City of Seguin, Texas.

SECTION THREE. This ordinance will be effective on JULY 16, 2021.
