**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, REPEALING ORDINANCE NO. 07-101 AND ORDINANCE NO. 2011-69; ESTABLISHING A SAVINGS CLAUSE; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of Seguin, Texas, previously adopted Ordinance No. 07-101, titled "AN ORDINANCE OF THE CITY OF SEGUIN TO TAX TANGIBLE PERSONAL PROPERTY IN TRANSIT WHICH WOULD OTHERWISE BE EXEMPT PURSUANT TO TEXAS TAX CODE SECTION 11.253"; and

**WHEREAS**, the City Council of the City of Seguin, Texas, also previously adopted Ordinance No. 2011-69, titled "AN ORDINANCE OF THE CITY OF SEGUIN TO TAX TANGIBLE PERSONAL PROPERTY IN TRANSIT WHICH WOULD OTHERWISE BE EXEMPT PURSUANT TO TEXAS TAX CODE SECTION 11.253"; and

**WHEREAS**, the City Council has determined that Ordinance No. 07-101 and Ordinance No. 2011-69 are no longer necessary, desirable, or consistent with the current policies and objectives of the City; and

**WHEREAS**, the City Council deems it to be in the best interest of the public welfare of the citizens of Seguin to repeal said ordinances;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, THAT:**

**SECTION 1. REPEAL.** Ordinance No. 07-101, titled "AN ORDINANCE OF THE CITY OF SEGUIN TO TAX TANGIBLE PERSONAL PROPERTY IN TRANSIT WHICH WOULD OTHERWISE BE EXEMPT PURSUANT TO TEXAS TAX CODE SECTION 11.253," adopted on November 6, 2007, is hereby repealed in its entirety.

**SECTION 2. REPEAL.** Ordinance No. 2011-69, titled "AN ORDINANCE OF THE CITY OF SEGUIN TO TAX TANGIBLE PERSONAL PROPERTY IN TRANSIT WHICH WOULD OTHERWISE BE EXEMPT PURSUANT TO TEXAS TAX CODE SECTION 11.253," adopted on December 6, 2011, is hereby repealed in its entirety.

**SECTION 3. SAVINGS CLAUSE.** The repeal of the aforementioned ordinances shall not affect any rights acquired, fines, penalties, forfeitures, or liabilities incurred thereunder, or any action, suit, or prosecution pending under such ordinances at the time of this repeal. All such rights, fines, penalties, forfeitures, and liabilities may be enforced and prosecuted as if said ordinances had not been repealed.

**SECTION 4. SEVERABILITY.** Should any section, paragraph, sentence, clause, phrase, or word of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such invalidity shall not affect the remaining portions of this Ordinance, and it is hereby

declared to be the intent of the City Council that it would have passed the remaining portions of this Ordinance irrespective of any such invalid portion.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall become effective immediately upon its passage and adoption by the City Council.
