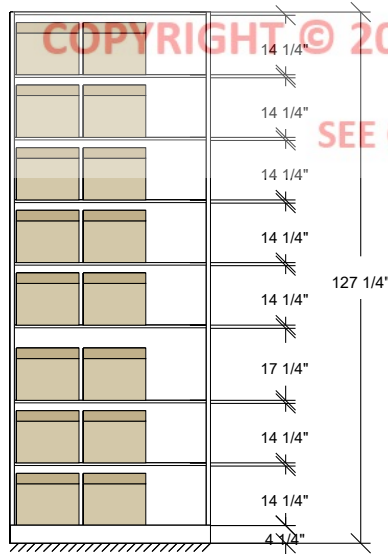

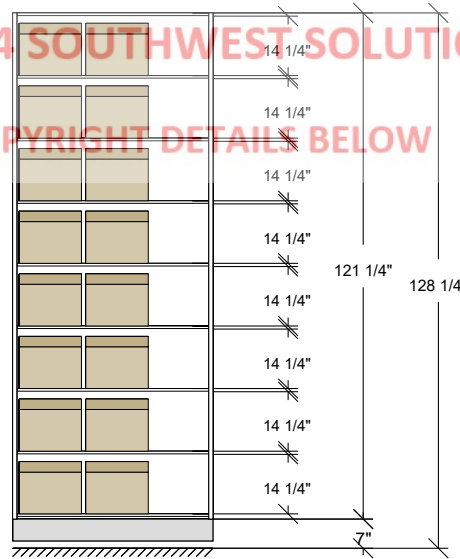
System 1 bin capacity of 736

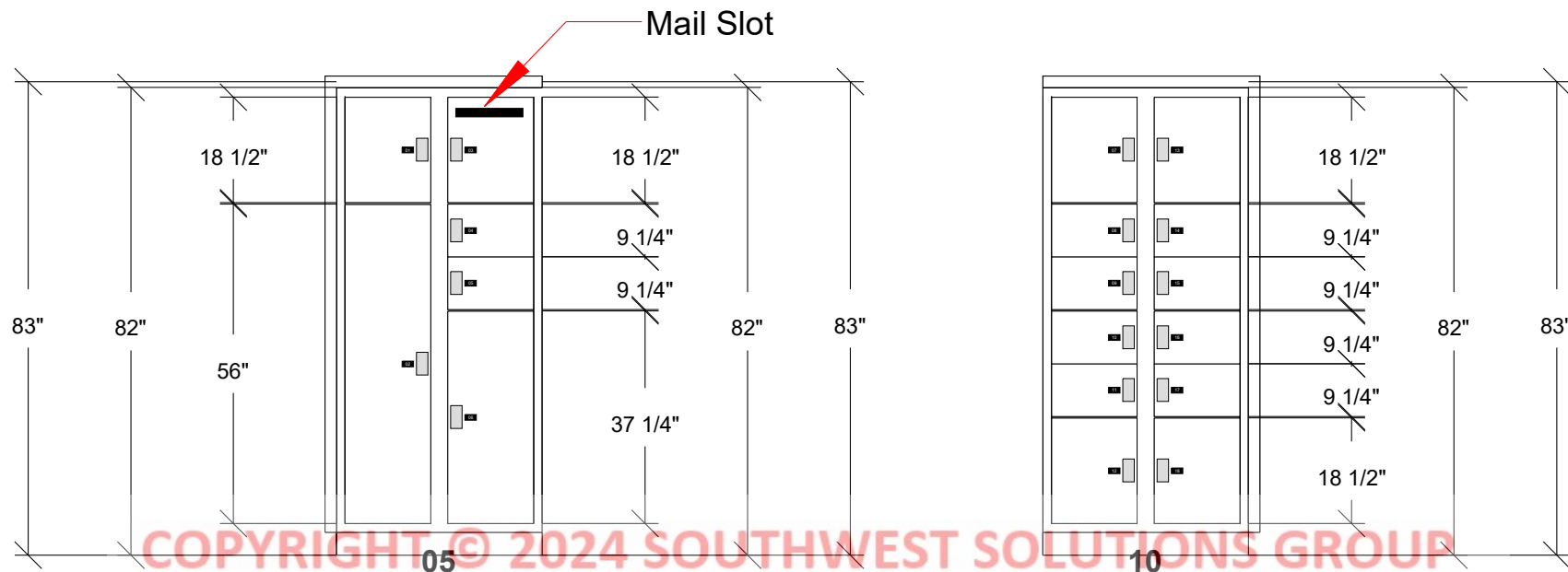
