CITY OF SEGUIN

AN ORDINANCE OF THE SEGUIN CITY COUNCIL ESTABLISHING A TEMPORARY CONSTRUCTION LAWFUL SPEED LIMIT ON IH-10 From FM464 to SH130 INCLUDING THE EAST BOUND AND WEST BOUND FRONTAGE ROADS AND A PORTION OF FM78, ALL WITHIN THE CITY OF SEGUIN, TEXAS; PROVIDING FOR PENALTIES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR PUBLICATION OF THIS ORDINANCE

WHEREAS, the Texas Department of Transportation ("TxDOT") is beginning a major construction project to add capacity to IH-10 within the City limits and to perform maintenance on the road; and

WHEREAS, the effected area of IH-10 will be from FM 464 to SH 130; and

WHEREAS TxDOT has determined that the 75 MPH speed limit should be reduced in the construction zone; and

WHEREAS, the aforementioned investigation has found that the following speed reductions are warranted as shown on the attached three exhibits; and

WHEREAS, this reduced speed limit shall be in force as marked by signs displayed during the construction period.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin as follows:

Part One. A temporary construction speed limit of 65 MPH is established on IH 10 from milepost 11.492 (FM464) to milepost 16.567 (SH123 Bypass); and marked by signs during the TxDOT construction project.

Part Two. A temporary construction speed limit of 60 MPH is established on IH 10 from milepost 16.567 (SH 123 Bypass) to mile post 21.682 (SH 130) and marked by signs during the TxDOT construction project.

Part Three. A temporary construction speed limit of 45 MPH is established on the Eastbound frontage road to IH 10 from milepost 13.571 to milepost 15.143 and marked by signs during the TxDOT construction project.

Part Four. A temporary construction speed limit of 40 MPH is established on the Eastbound frontage road to IH 10 from mile post 15.143 to 16.567 and marked by signs during the TxDOT construction project.

Part Five. A temporary construction speed limit of 45 MPH is established on the Westbound frontage road to IH 10 from milepost 11.492 to milepost 15.143 and marked by signs during the TxDOT construction project.

Part Six. A temporary construction speed limit of 45 MPH is established on FM 78 is from milepost 17.459 to 18.0059 and marked by signs during the TxDOT construction project.

Part Seven. Violations of this Ordinance shall be punished in accordance with the penalty provisions of the City of Seguin Code of Ordinances.

Part. Eight. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.

Part nine. In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following its passage and shall be published in a newspaper of general circulation.
