**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS
AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES
AGREEMENT IN THE AMOUNT OF \$59,730.00 WITH HALFF & ASSOCIATES, INC.
FOR THE ALDAMA-WALNUT SPRINGS TRAIL CROSSING; AND DECLARING AN
EFFECTIVE DATE.**

WHEREAS, the City wishes to maintain a continuous, comprehensive, and coordinated transportation network to ensure that the transportation network of this community promotes access for all modes in the safest feasible manner; and

WHEREAS, the Aldama-Walnut Springs Trail Crossing will incorporate multimodal forms of transportation by providing pedestrian and bicycle paths crossing man-made barriers; and

WHEREAS, the existing Walnut Springs Trail sidewalk along W. Kingsbury Street does not meet adequate safety buffers between roadway and sidewalks as required by the TxDOT Roadway Design Manual; and

WHEREAS, Halff & Associates, Inc. is on the City's indefinite delivery/indefinite quantity (IDIQ) list of qualified engineering firms to provide professional engineering services to the City in the roadway, bridge, structural, and general civil engineering categories; and

WHEREAS, Halff & Associates, Inc. was authorized to perform the South Washington Street Drainage Improvements Preliminary Engineering Report whereas recommendations were provided for the South Camp Street Drainage Improvements; and

WHEREAS, the services to be performed by Halff & Associates Inc. for the Project includes detailed construction documents for the Aldama-Walnut Springs Trail Crossing Project; and

WHEREAS, city staff negotiated a professional services agreement with Halff & Associates, Inc. for the purposes of final design; and

WHEREAS, City staff recommends entering into a professional services agreement for this Project pursuant to the Agreement with Halff & Associates, Inc.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Seguin, Texas:

SECTION 1. The City Council of Seguin, Texas hereby approves a Professional Services Agreement in an amount of \$59,730.00 with Halff & Associates, Inc. for engineering services for the Aldama-Walnut Springs Trail Crossing Project.

SECTION 2. This resolution is effective on the date of its passing.
