A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, AUTHORIZING THE PURCHASE AND FINANCING OF TEN (10) STRYKER LIFEPAK 35 HEART MONITOR/DEFIBRILLATORS FOR THE SEGUIN FIRE DEPARTMENT IN THE TOTAL AMOUNT OF \$546,775.60; AUTHORIZING THE TRADE-IN OF NINE (9) EXISTING LIFEPAK 15 UNITS; AUTHORIZING A MULTI-YEAR FINANCING AGREEMENT NOT TO EXCEED FOUR (4) ANNUAL PAYMENTS OF \$185,000; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Seguin (the "City") Fire Department utilizes heart monitor/defibrillators, specifically the Stryker LIFEPAK 15 models, as essential life-saving equipment on all fire apparatus; and

WHEREAS, the current inventory of LIFEPAK 15 devices are reaching their end-of-life (EOL) status, with some versions having been designated EOL as of September 2023, and the standard operational lifespan for the LIFEPAK 15 is eight (8) years, after which maintenance, parts, and service become increasingly difficult to obtain; and

WHEREAS, the new Stryker LIFEPAK 35 monitor/defibrillator utilizes modern computer software and finite technology to increase the accuracy and reliability of field diagnosis for various medical conditions; and

WHEREAS, the Fire Department staff is recommending the purchase of the Stryker LIFEPAK 35 to ensure consistency and interoperability with the City's existing inventory of Stryker medical products, including AEDs, cardiac compression devices, stretchers, and powerload systems, thereby streamlining maintenance and accessory inventory; and

WHEREAS, this capital acquisition project was duly approved and included within the City's Fiscal Year 2026 Budget (FY2026); and

WHEREAS, the Fire Department staff recommends financing this multi-year purchase through a third-party financial institution, utilizing four (4) annual payments, with each annual payment not to exceed One Hundred Eighty-Five Thousand and 00/100 Dollars (\$185,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS:

Part 1. The City Council hereby authorizes the purchase of ten (10) Stryker LIFEPAK 35 heart monitor/defibrillators for the Seguin Fire Department in the total amount of **\$546,775.60** and the trade-in of nine (9) existing Stryker LIFEPAK 15 units as part of the total purchase price, pursuant to Texas Local Government Code, Section 252.022(a)(2) and (a)(7)(D).

Part 2. The City Manager is hereby authorized to execute a multi-year financing agreement with a third-party financial institution to fund the purchase, provided that the total annual debt service payment for the four (4) annual payments shall not exceed **\$185,000.00** per year.

Part 3. This Resolution shall become effective immediately upon its passage and adoption.
