Subject: Resolution to Apply for Flood Infrastructure Funding for Seguin
Regional Drainage Masterplan

Historical Background

The city submitted an abridged application for Texas Water Development Board (TWDB), Flood Infrastructure Funding (FIF) in late 2024. This application included several proposed flood and drainage related projects for funding. In September the city was invited to submit a full financial assistance application for one of those proposed projects, the Seguin Regional Drainage Masterplan Update. This second half of the application process provides TWDB with more detailed financial, legal, engineering information for a technical application review. As part of the application process the city held a public hearing for the project at the last City Council meeting.

Passed by the Legislature and approved by Texas voters through a constitutional amendment, the FIF program provides financial assistance in the form of loans and grants for flood control, flood mitigation, and drainage projects. The FIF program provides opportunities for loans with an interest rate of 0% and grants for cities, counties and eligible districts. The FIF program allows for a wide range of flood projects. Only Flood Management Evaluations (FME), Flood Mitigation Projects (FMP), and Flood Management Strategies (FMS) recommended in an amended regional flood plan approved by the TWDB are eligible for financial assistance.

The project under consideration for funding is to expand the Seguin Drainage Master Plan. This update would include incorporating Youngs Creek, Cottonmouth Creek, Geronimo Creek, and Long Branch-Mill Creek watersheds to the plan scope and conduct studies to be used for hazard mitigation planning along these channels. As extreme weather events and flood waters do not recognize jurisdictional boundaries, like county and city limits, partners will work together to address flooding as a regional issue. The proposed Seguin Regional Drainage Masterplan will provide a basis to identify flooding vulnerabilities for existing infrastructure and impacts from future growth to improve flood resilience in the watershed, thus making those projects eligible for future FIF funding.

The city is estimating the total project cost to be \$1.1 million. Of that amount, \$825,000 would be grant funded, and the remaining \$275,000 would be funded by a TWDB FIF Zero Percent Interest loan.

Action Requested

City Council must approve the resolution to authorize the submission of this grant application.

Procurement Methodology & Funding Source

If the grant is awarded, 75% of the funding will be secured through the grant and 25% will be from a Zero Percent Interest Financing loan from the Texas Water Development Board.

Procurements will be made according to the City of Seguin Purchasing Policy

Staff Recommendation

Staff recommends approval of the resolution to authorize the submission of the grant application.
