AN ORDINANCE OF THE CITY COUNCIL OF SEGUIN, TEXAS AMENDING SECTION 98-109(c), TO CREATE PARKING BY PERMIT AREA B; AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE AS A SUPPLEMENT TO THE CITY CODE OF ORDINANCES; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION; AND DECLARING AN EFFECTIVE DATE

WHEREAS, the city Council has determined that Section 98-109(c), Parking by permit only, Designated permit areas be amended in order to protect the health, safety, and welfare of the citizens.

BE IT ORDAINED BY THE CITY COUNCIL OF SEGUIN, TEXAS

SECTION ONE. The Seguin Code of Ordinances, Section 98-109(c) is amended to read as follows (<u>underlining</u> indicates added text, strikethrough indicates deleted text):

Sec. 98-109. Parking by permit only.

- (c) Designated permit areas. No person shall park and leave standing any vehicle whether attended or unattended between the times listed and locations designated below without first having obtained a valid parking permit for the designated permit area from the city. Said designated permit area shall be designated as a tow away zone:
 - (2) Area B, daily, year-round.
 - a. On both sides of Jay Road between the westbound IH-10 Frontage Road and the terminus of Jay Road.
 - <u>b.</u> The City hereby establishes a permitting program in collaboration with hotels that have frontage on Jay Road, wherein hotels may issue temporary permits that allow hotel guests to park along Jay Road for the dates and times of their hotel stay. The City shall maintain the right to limit the number of temporary permits allocable to a participating hotel, or to disallow use of temporary permits by a participating hotel if permit holders are determined by agents of the City to be in violation of the terms and conditions of the temporary permit, including but not limited to terms and conditions related to littering.

SECTION TWO. This Ordinance shall be reviewed approximately six months after its effective date for compliance; any complaints received for non-compliant parking or littering will be presented to Council approximately six months after the effective date of this ordinance for discussion and potential direction to staff.

SECTION THREE. This Ordinance shall become effective beginning ten days after its publication.

SECTION FOUR. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

SECTION FIVE. City Staff is hereby authorized to submit this Ordinance as a supplement to the Seguin Code of Ordinances.
