AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 74, PARKS, SECTION LL, SEGUIN EVENTS COMPLEX RENTAL, TO SET THE FEES FOR RENTING FACILITIES, AMENITIES AND SERVICES; PROVIDING FOR A SEVERABILITY CLAUSE; DECLARING AN EFFECTIVE DATE; AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES

WHEREAS, the City of Seguin will commence overall operations and maintenance of the Seguin Events Complex on January 5, 2016; and

WHEREAS, the Seguin Events Complex will be available for public use and rental; and

WHEREAS, City staff recommends setting facility rental fees for the use of the Seguin Events Complex consistent with the fees that are charged for similar facilities in the area and what was previously charged by the Guadalupe County Fair Association.

NOW THEREFORE, BE IT ORDAINED by the City Council of Seguin, Texas:

Section 1. Appendix C – Fee Schedule, Chapter 74, Parks and Recreation is amended by the addition of a new subsection ll to read as follows:

ll Seguin Events Complex Facility Rental Rates:

- (1) Rodeo Arena Rental: Weekday (Monday through Thursday, 7:00 a.m. to 2:00 am. and includes initial arena dirt preparation and warmup area).... \$250/day
- (2) Rodeo Arena Rental: Weekend (Friday through Sunday, 7:00 a.m. to 2:00 a.m., and includes initial arena dirt preparation and warmup area).... \$400/day with 20 stalls included
- (3) Rodeo Arena (Friday evening, in addition to full weekend rental, 5:00 p.m. to 2:00 a.m.).....\$250.00 with 20 stalls included.
- (4) Rodeo Arena Riding Fee.... \$20/month \$100/annual
- (5) Stall Rental.... \$15/stall (noon to noon)
- (6) RV Hookups.... \$25/day (noon to noon)
- (7) Stall Office Rental.... \$25/day
- (8) Timer Rental.... \$30/event
- (9) Pole Rental.... \$5/pole/event
- (10) Barrel Rental.... \$5/barrel/event
- (11) Panel Rentals.... \$5/panel/event
- (12) Roping Pad Rental.... \$5/pad/event
- (13) Dirt Preparation during Rental (no tractor rental) \$5/occurrence
- (14) Nelda Street Closure (with sand on roadway).... \$275/event (requires City Council approval)
- (15) Nelda Street Closure.... \$50/event (requires City Council approval)

- (16) Vendor Space Rental (includes 110 hook up).... \$30/day (midway)
- (17) Ticket Booth Rental.... \$100/event
- (18) Livestock Barn Rental.... \$250/day
- (19) Swine Barn Rental.... \$250/day
- (20) Dance Slab and half of Women's Building.... \$400/day
- (21) Hall of Fame Rental.... \$100/day
- (22) Shavings.... \$10/bale
- (23) Removal of Shavings from Stalls.... \$5/stall
- (24) Removal of Shavings from Livestock Barn.... \$300/event
- (25) Concessions Stand Rental.... \$30/day (\$100/day for all seven stands)
- (26) Security Deposit.... \$250.00 to \$2,500.00 depending on facilities rented.

Section 2. This ordinance shall be effective upon ten (10) days following passage on second reading and shall be published in a newspaper of general circulation.

Section 3. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

Section 4. City Staff is hereby authorized to submit this Ordinance as a supplement to the Seguin Code of Ordinances.
