Director of Main Street, Kyle Kramm gives an Update on Downtown Seguin Investment, Recent investments, and Data; In 2022, almost \$7 million was reinvested into downtown Seguin. Since 2015, almost \$35 million has been reinvested in downtown Seguin. Over 15 new businesses opened in downtown Seguin during 2022. 17 buildings were sold, 36 rehab projects were completed and 5 public projects were completed. Main St. Program recorded 269 volunteer hours in 2022. Sales Tax Collections by downtown merchants have increased by 70% from 2018. The average appraised value per square foot in downtown Seguin increased by 44% from 2018. the new cafe and bookstore opened in May of 2022, Pecantown Books & Brews; The conversion of the residential structure into commercial property included the addition of ADA pathways, an ADA restroom. The Seguin Art League purchased 104 South Austin in 2014, the gallery opened in May of 2022. The former Starcke Sleep Shop was purchased, and three new tenants now occupy the building; Mas Knifehaus, Seguin Botanical and the One and Only Tattoo, all opened during 2022. The Mercantile @ Southern Good, Men's Clothing Boutique opened by owners of the Southern Goods Boutique. Businesses becoming property Owners; Burnt Bean Company, Traveling Gypsy, and Seguin Bar & Billiards all purchased their buildings in 2022. Investors Find Value in Downtown Properties, Multiple properties were purchased by investors, local families who see value in downtown Seguin; properties purchased included \* 314 N. Austin \*107 N.Austin \*106 & 108 N. Austin \*200 E. Court. After being struck by lightning causing a fire in 2021, Mosheim Mansion was purchased and saved. The addition of the BIG Program, Business Improvement Grant has been a driving force for downtown businesses and property owners to make investments in their properties. Upgrades to HVAC systems, ADA improvement and more. The facade grant has been a successful grant program for downtown seeing three dollars of private money

invested for every public dollar. The facade grant goes to any exterior improvements.

The Goals are to \* Develop baseline data \*Establish current water supplies \* Formulate future water demand projection through 2080 \* Determine future water supply needs and identify supply alternatives.

Discussion and Update regarding Meadowlake Dam with possible direction to staff

*City Manager, Steve Parker spoke on how the City of Seguin has been working very close with the Meadow Lake Dam Association and now created a WCID and working with GBRA in trying to find an affordable solution to resolve the Dam situation. Stated that Meadow Lake a taking on a large role in finding a solution. The Meadow Lake Dam Association has done a fundraiser to pay for a study, they have given the money to the City of Seguin and the City of Seguin has enacted a contract with Freese & Nichols and that study is near completion. Objective is to find a way to save Meadow Lake. If it were to stay that way permanently property value will drop, and the Cities property income would go down. GBRA has laid out some very specific guidelines. Mr. Parker states the last thing would be to come up with a firm number that GBRA is comfortable with and is an acceptable solution. Mr. Parker states that if we are able to get to that point there will be more opportunity to continue negotiation, the goal would be to call an election for WCID for debt issuance, debt rate at the November elections to see if community and Meadow Lake would consider the high taxes, they would be funding the majority of that and in the future the City could possible step in for the difference. The de watering system would be the last thing, Freese & Nichols is contemplating an over bridge crane that could be installed to move the materials that would create the de watering system. Meadow lake would need to go back to fundraising to complete this project, projected date was to be in August. The staff is recommending if the council is agreeable to loan them the money and Meadow Lake can fundraise to pay back the loan or the City can put it in the Bond Election and reimburse ourselves. That is the status.*

*Council member Paul Gaytan spoke on why saving Meadow Lake is in the best interest of our City as a whole and not just those one hundred and twenty residents at Meadow Lake, property values, recreational tourism and also the environmental issues that will occur.*

*Tess Coody-Anders, 210 S Heideke, Seguin, Texas 78155, Ms. Coody states that Meadow Lake and the river is one of those unique distinguishing characteristics in our community that we all share in. Stating that there are several people that come to Pecan Town who are there to stay on the lake, to kayak, paddleboard and to fish with their kids. If we fail to find a solution, there will be real and dramatic impacts to the entire community through impact to tax revenue.*

*Michael Meskill, 1101 Loch Lane, Seguin, Texas 78155, Mr. Meskill spoke on the economic impact it would have if the dam was not rebuilt, stating that Meadow Lake is an economic stimulus, it brings economic benefits to the City of Seguin.*

*Andy Taylor, 1290 Loch Lane, Seguin, Texas, 78155, Mr. Taylor states that the results of keeping Meadow Lake drain are not good for the community. Also stating that Mr. Parkers states earlier is a great description of the situation and what needs to happen to repair the Meadow Lake Dam.*

*Douglas Parker, 188 Wampum Way, Seguin, Texas, 78155, Mr. Parker states he has*

two lots that were waterfront, and not creek front. Mr. Parker states that for years now Main Street Department Director Kyle Kramm and Economic Development Director, Joshua Schneuker and the Business Alliance have been promoting tourism in the City of Seguin.

Chester Jenke, 116 N. Camp, Seguin, Texas, 78155 spoke on the depreciation of the home value on a home in the lake community, stating that after twenty four months, thirty three percent of a home value on Lake Dunlap was lost. Mr. Jenke states that is significant especially when your looking at a school district or county, or when looking at the City Taxes part of it.

Mayor Donna Dodgen ask council member if they all agreed with City Manager Parker's thoughts and direction. All gave consent for City Manager to go in the direction he felt was best.
