McQueeny, Texas - Spoke on how he has reached out to the City requesting what a general area is on water service. An agreement that he has states that water service is provided by Spring Hills, stating the he can not get a reply from the Planning/Codes department on where the water line is. Mr. Milam stated that his property is less than a thousand feet wide, annexations still continues to proceed. He stated that he is not getting the answers for the questions he has been asking, and stated that this property should not be annexed, and wants City Council to vote 'No" on annexation of his property.

*Council Member Aviles asked if there was anyone here tonight that could answer Mr. Milam's questions.*  City Manager, Steve Parker spoke on the questions asked by Mr. Milam and stated that service territory for city's water supply is defined by the Public Utility Commission, and they have set areas that they have decided who would service each particular property with water and sewer service, the maps are all online with the Public Utility Commission; and if he wants to get water from a provider. The City of Seguin cannot legally serve him water. This annexation was a development agreement as long as the property remained in Agriculture status that would be fine, but if it were to be developed then the property would have to be brought up to the City's Code Standards.,Mr. Milam did not meet any of the deadlines to come up to code.

Council Member Roy asked if we were going to make Mr. Milam tie on to a water line.

Deputy City Manager, Rick Cortes stated that if he has a water well he can use that and that the City would not make him tie on to a water line.
