*Attorney Kimbrough stated City Attorney, Andrew Quittner began by stating this process started in December of last year with the passing of a couple of resolutions to set the perimeter and guidelines for redistricting which is required every 10 years when the census comes out and required if you are out of balance, Seguin grew between 2010 and 2020 to 75 percent out of balance with the district with the most and the district with the least amount of people.*

*City Council appointed six people to serve on a committee, they met three times in public meetings to discuss, draw maps and do what needed to be done to reach a recommendation for City Council and they did a good job. Two maps and a base map was presented and posted on the website for an open meeting. Maps needed everyone here sitting in their districts to continue to be in the same district by way of charter; One person one vote rule meaning the districts are equal in population and that is defined as 10 percent or less and maintain majority and minority. Two maps were recommended,*

*Mayor Donna Dodgen gave thanks to each member of the committee stating it was a lot of hard work, we really appreciate your work.*

*Each redistricting committee member spoke:*

*Jason Bisenbach:*

*632 E Cedar*

*Seguin, Texas 78155-It was a pleasure and an experience. Stated he wanted to represent District 7 since at this time District 7 does not have representation. Mr. Bisenbach spoke on the differences with each map according to the initial assessment and looking at Plan C full district map it looks similar to the City's current District maps, looking at the current district break down map you will see the geographic boundaries and the neighborhoods are all maintained. Looking at Plan G district map you can see that Districts 1,2,3 and 7 really get away from the initial assessment. Also has a huge minority drop. Plan C and Plan E both follow City Council redistricting guidelines. Plan G does not and does not follow natural boundaries. Mr. Bisenbach recommends Plan C.*

*Tony Tolic:*

*Seguin, Texas 78155 - Gave his recommendation as Plan C for the same reasons as Jason Bisenbach gave also wanted to thank City Attorney, Andrew Quittner and Charles R. Kimbrough of Bickerstaff, Heath, Delgado, Acosta, LLP for having the correct numbers and correct information it was much appreciated. Numbers used for Plan G were not correct.*

*Paul Castillo*

*37 Glen Cove Dr.*

*Seguin, Texas 78155 -- Stated he was amazed that they had such intelligent people in the committee. Mr. Castillo spoke on how this year Seguin has seen such a large growth and believe it will continue so much so that in five year a redistrict will need adjusting, now the change has to happen. He stated he is surprised that the Hispanic community has grown outside of where it has always been. Not everyone is staying where they were born or raised anymore. Plan G is a change and he would like everyone to keep that in mind.*

*Jessie Trinidad:*

*Seguin, Texas 78155 - Mr. Trinidad state, that he wanted everyone to know that he supports Plan G; stating they had some trouble in drawing their map because they did not have all of the information needed and were short on time. He feels the map maintains the form with minority districts. Mr. Trinidad feels that Plan E distributes the Hispanics throughout the eight districts and dilutes the voting strength of Hispanics. He also gave thanks to the committee stating everyone worked very well together. Mr. Trinidad complimented the City Council stating it is one of the best City Councils ethnically formed and gave them thanks.*

*Mayor Donna Dodge: Thanked the Committee once more.*

*City Attorney, Andrew Quittner stating that he did not know if redistricting would be called for again in five years, it would depend on council if they wanted to go through another census and if the funding was there. Also stating that the City of Seguin has already grown two- thousand or so people since 2020 and it is going to get tougher at some point because the city is grown very asymmetric at some point it is going to take some major changes in districts to keep them balanced. It will be a real challenge.*

*The regular meeting was recessed and the public hearing was called to order.*

*Charles R. Kimbrough introduced his colleague, Sheri McCall, head of their GIS Services and first time to appear in person, has been on the phone during the redistricting meetings. The last time Mr. Kimbrough was with council was the initial assessment day in March and the numbers were shown that the City was out of balance, 77 percent out of balance and it needs to be under 10 percent. April 11th the City Attorney's and City Manager's Office requested that some drawings be produced to present to the committee so we drew A,B, and C. First committee meeting the majority of the discussion was about Plan C, Second committee meeting was April 20, 2022 other plans were drawn Plans E and D, all plans after that first meeting were a derivative of Plan C. The committee gave council two plans to consider Plan E and Plan G. Mr. Kimbrough stated that it is his role, his firms role is to give their recommendation on which Plan the City should chose. Plan C was the one recommended by Charles R. Kimbrough. Reason when data was reviewed District 1 and 2 and 4 and 5 their were dramatic majority of Hispanic voting age population counted by the census; over sixty-six percent in District 1, over sixty-five percent in District 2,*

over sixty-six in District 4, and over sixty-one in District 5. Hispanic voting age populations was used as the first marker; SSRV Number - Spanish Surname Registered Voters data as second marker. To summarize Plan C out performs Plan E and Plan G. Plan C has a maximum deviation of 6.57 percent balance and is balanced. Council Member Roy questioned the percentages in District 2, under Plan G had a negative 11.21 drop in the Hispanic voting age populations and a 14.88 percent drop and are numbers that can not be ignored per Attorney Kimbrough.

Council member Roy asked who drew the Plan G, it was drawn based on a drawing given by Paul Castillo and Jessie Trinidad. Plan G has been endorsed as an advantage to Hispanic voters and trying to raise the Hispanic voters in District 3.

Paul Castillo stated that we have a diversity of people in this community, and like to look at voting age population. He continues to state that in 2011 District 4 was diluted to an area with an amount would that we though would effect the peoples choice when voting. Our main concern is District 3, it has been diluted in every map above thirty percent of voting age population, we are looking for a fair number. Mr. Castillo recommendation is Plan G.

Tony Tolic stated his recommendation is Plan C because when you look at the numbers the only districts that go up on Hispanic voters is District 1 and District 3 on Plan G, all other districts decrease in the Hispanic votes and Black votes. Ms. Miller who is part of the Redistrict committee as well endorses Plan C. Plan C does not make numbers drop as Plan G does.

Council Member Aviles asked that if one of the big concerns was dropping below sixty percent?

City Attorney, Andrew Quittner explained the sixty percent rule.

Council Member Roy stated Plan G when submitted to the committee looks good on paper but numbers were wrong and put the deviation in 2 out of scope, and beyond the bounds of the law.

Attorney Kimbrough stated Plan G presents a risk issue that we could not remain silence about. The Plan C, the Plan E and the Plan G took measures to make sure every council resident remain within their district

Council Member Aviles asked what would be the probability that redistricting would have to been done again within five years knowing how District 3 is going through sure a large growth right now.

City Attorney, Andrew Quittner stating that would be a council decision, there are procedures for doing census out of the decennial. City would have to fund the census. City Manager, Steve Parker; stated it is very rare for a City to have to do their own census. City Attorney, Andrew Quittner stating it could cost 30 to 35 Thousand dollars to hiring people and do all the counting.

Attorney Kimbrough also stated that it is of their opinion that each of the Plans are in compliance with criteria guideline resolution that was passed on December 7, 2021 it is just our judgment on behalf of the law firm that the Plan C out performs the other two, E Plan and G Plan on the criteria.

*Council Member Joe Rea stated the Plan C and Plan E look identical to him, and asked to be explained the difference between the two.*

*Attorney Kimbrough stated, to look at the Plan C Hispanic voting age population, continued to read the Plan Comparison sheet and the percentages of positive versus negative between the Plan C and the Plan E showing that the Plan C show a high percentage of Hispanic voting age population than what was shown in the Plan E therefore given the difference between the two.*

*Mayor Donna Dodgen asked if there were any questions on the drawing.*

*Council Member Chris Rangel stated that looking at Plan G, question the shape of the drawing stating that District 4 shape would be completely different and it seems to him that each district would be imposing on District 4 from every side. Stating that there would be several small streets in the area, all in different districts.*

*Attorney Kimbrough stated, at the three committee meetings during the drawing of the plans when the lines were moved the numbers changed and was not balance.*

*City Attorney, Andrew Quitter stating the city is divided into census blocks that we don't determine, and when the drawing lines are moved they have to be moved census block by census block, cannot move street by street. That is what caused the different shapes.*

*Attorney Kimbrough stated that the recent annexations have been included as part of the City territorial boundary map right now, also stated that they are volunteer annexation and have been included in the district as well.*

*Council Member Herbold stated as to it appears to him that the folks putting the Plan G together are willing to give up a percentage in District 2 thinking they can still hold that and pick up ten points in District 3. He feels that is the whole point on the Plan G being what it is.*

*Attorney Kimbrough stated the numbers don't lie and to get those numbers in District 3 there is a significant change in District 2 and District 4, those are the risks that we cannot be ignore in terms of the Firms advice.*

*Mayor Donna Dodgen stated that she believes that what we are seeing are growing pains and it is going to be messy and maybe in ten years it may messier or change significantly and those are her thoughts.*

*Attorney Kimbrough stated that the timing to vote would be this evening if they are ready.*

*City Attorney, Andrew Quitter stated the effective date will be June 1, 2022, but County Elections Office needs it by May 17, 2022 and people need to know where they live to be ready to vote in November.*

*Council Member Roy asked Mayor if she is asking one of the council members to make a motion in approving one of the plans.*

*Mayor Dodgen stated yes.*

*City Attorney, Andrew Quitter stating the charter requires two readings and motions.*

Council Member Roy made a motion, but would like to state why he is making this particular motion, he feels that when the folks that prepare Plan G created it they did not have the correct numbers and then they were corrected but then showed a large variance in District 2. Also stating that it looks like the majority of the redistricting committee is endorsing Plan C and the Firm is also endorsing Plan C so he is going to make a motion that the City Council approve Plan C. Council Member Herbold seconded the motion to approve Plan C.

Council Member Rangel asked if the committee knew that there was an -11.21 deviance?

Attorney Kimbrough stated that Mr. Castillo brought documents to Committee meeting on April 25, 2022 and that he asked him if he had shared our information with a third party and Mr. Castillo stated yes, he had shared it with MALDEF ( Mexican American Legal Defense and Education Fund) so when the data came across from the MALDEF Lawyers there was a discrepancy about the city boundary lines and we had to adjust the lines on that plan to fit the jurisdictional aerals that city council gave to the firm to start this project.

City Manager Steve Parker stated that when everyone left that night the numbers were known by all parties, three members out of the committee voted Plan G, three for Plan E, after they thought about it they like the numbers for Plan C, and two members wanted Plan G and both those members still want Plan G as they have both stated today.

Attorney Kimbrough stated that his role nor Mr. Quittner's role was not to influence the committee members to do one or all or none, but the Plan C was a Bickerstaff plan at the very first committee meeting because of the large Hispanic majorities in districts 1, 2, 4, and 5.

Mayor Donna Dodgen asked Mr. Castillo if he had any questions.

Mr. Castillo, Committee member; stated on a three to three vote we submitted Plan E and Plan G and I don't know how Plan C worked its way in and I don't know how the other three committee members changed their mind, but we drew the map, we know the communities and the time we had was limited. Also that this process should have been started a long time ago. Mr. Castillo stated that each council member is really working for every citizen in city not just their own district.

Mayor Donna Dodgen asked City Attorney to explain why the redistricting began when it did.

City Attorney, Andrew Quittner stated that part of it was that we were waiting on Guadalupe County to divide up precincts and voting precincts. Another reason would be the data came late, it should have been here a year ago, but we got it September into October. Then a committee needed to be formed and that took some time to gather six people.

Mayor Donna Dodgen asked if anyone else had any questions.

Council Member Aviles said that he wanted to make a comment that everyone's hard work was much appreciated.

*City Attorney, Andrew Quittner stated the motion needed to be individually counted numbers for and against.*
