AN ORDINANCE OF THE CITY COUNCIL OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES CHAPTER 98, SECTION 98-103, RESERVED PARKING; AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE AS A SUPPLEMENT TO THE CITY CODE OF ORDINANCES; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION; AND DECLARING AN EFFECTIVE DATE

WHEREAS, areas of City right-of-way are reserved for specific parking based on location.

BE IT ORDAINED BY THE CITY COUNCIL OF SEGUIN, TEXAS

SECTION ONE. The Seguin Code of Ordinances, Chapter 98, Traffic and Vehicles, Article V, Stopping, Standing and Parking, Section 98-103(a) is amended to read as follows (underlining indicates added text, ~~strikethrough~~ indicates deleted text):

The following areas shall be designated as reserved for specific parking as described therein:

- ~~(1) Both sides of East Center Street between Austin and River Streets will be designated as parking for county officials, and there will be no two-hour parking limit imposed on county officials when parking in these areas.~~
- (12) The west side of the courthouse on South Austin Street will be designated as parking for law enforcement personnel. There shall be no two-hour restriction on parking by law enforcement personnel in marked vehicles.
- ~~(3) The east and north side of the courthouse will continue to be two-hour parking for members of the public. Any person may park in this area, provided that he parks for no longer than two hours.~~
- ~~(4) On the southwest corner of the intersection of South River and East Center, a sign will be placed with an arrow indicating the direction in which prospective jurors may find the appropriate parking. Prospective juror parking will be two blocks from the courthouse. The sign shall read, "jury parking 2 blocks." Additional signage will be placed in the locations where jury parking only is permitted. There shall be no two-hour limit on juror parking.~~
- ~~(5) On the southeast corner of the intersection of South Austin and East Center, a sign will be placed with an arrow pointing the direction in which prospective jurors may find parking. Parking for prospective jurors will be two blocks from the courthouse. The sign will read, "jury parking 2 blocks." Additional signage will be placed in the locations where jury parking only is permitted. There shall be no two-hour parking limit on juror parking.~~

SECTION TWO. This Ordinance shall become effective beginning ten days after its publication.

SECTION THREE. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

SECTION FOUR. City Staff is hereby authorized to submit this Ordinance as a supplement to the Seguin Code of Ordinances.
