**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, APPOINTING ROBERT BARFIELD AS AN ASSOCIATE MUNICIPAL JUDGE FOR THE CITY OF SEGUIN MUNICIPAL COURT OF RECORD; APPROVING AN AGREEMENT FOR PROFESSIONAL JUDICIAL SERVICES BETWEEN THE CITY OF SEGUIN AND ROBERT BARFIELD; PROVIDING FOR THE TERMS AND COMPENSATION OF SAID SERVICE; AND DECLARING AN EFFECTIVE DATE.**

**WHEREAS**, the Presiding Municipal Court Judge, Darrell S. Dullnig and the Court Administration, have identified a need for an Associate Municipal Judge to preside over dockets in his absence to ensure the efficient and continuous operation of the City’s judicial system; and

**WHEREAS**, the City Council finds that Robert Barfield is a qualified individual, licensed to practice law in the State of Texas, and possesses the necessary experience to serve in this judicial capacity; and

**WHEREAS**, the City Council desires to appoint Robert Barfield and enter into an agreement setting forth the terms, conditions, and compensation for his service as an Associate Municipal Judge.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS:**

**SECTION 1. APPOINTMENT.** The City Council hereby appoints Robert Barfield to serve as an Associate Municipal Judge for the City of Seguin Municipal Court of Record.

**SECTION 2. APPROVAL OF AGREEMENT.** The Agreement for Professional Judicial Services between the City of Seguin and Robert Barfield, attached to the Agenda materials, is hereby approved.

**SECTION 3. TERM OF SERVICE.** The term of this appointment and the associated agreement shall be for a period of two (2) years, commencing on April 15, 2026, and terminating on April 15, 2028, unless sooner terminated in accordance with the provisions of said agreement.

**SECTION 4. AUTHORIZATION.** The City Manager is hereby authorized to execute the Agreement on behalf of the City of Seguin and to take all actions necessary to implement the terms of the appointment.

**SECTION 5. EFFECTIVE DATE.** This Resolution shall be in full force and effect immediately upon its passage and approval.
