

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AWARDING A BID IN THE AMOUNT OF \$15,394,288.26 TO STERLING DELAWARE HOLDING COMPANY FOR THE RUDELOFF ROAD ROADWAY IMPROVEMENT PROJECT CSJ 0915-46-045; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONSTRUCTION CONTRACT WITH STERLING DELAWARE HOLDING COMPANY; AND DECLARING AN EFFECTIVE DATE**

**WHEREAS**, the City of Seguin is a member of the Alamo Area Metropolitan Planning Organization (the "AAMPO"); and

**WHEREAS**, in January 2017 the City was notified by the AAMPO that the Rudeloff Road Improvement Project (the "Project") was selected for funding; and

**WHEREAS**, on October 16, 2023, the City was awarded additional funding on its 2015 grant application to the Alamo Area Council of Government for TxDOT funding of the Rudeloff Road Improvement Project ("Rudeloff Road Project");

**WHEREAS**, the City contracted with BGE, Inc. to design the Rudeloff Road Project and assist in bidding of the project; and

**WHEREAS**, in response to the City's request the City received seven sealed bids for the Rudeloff Road Project; and

**WHEREAS**, the qualified bids ranged from a low base bid of \$13,003,472.26 submitted by Sterling Delaware Holding Company to a high of \$15,719,246.64 submitted by Sundt Construction, LLC, plus an additive alternate that ranged from \$ 2,072,651.25 to \$3,635,967.00; and

**WHEREAS**, after considering the bids, performing an extensive reference check by BGE and evaluation bid amount per unit price, and concurrence with TxDOT, the City recommends awarding the contract to the lowest bidder, Sterling Delaware Holding Company, with a base bid of \$13,003,472.26, plus the additive alternate in the amount of \$2,390,816.00 for a total contract price of \$15,394,288.26.

**NOW THEREFORE BE IT RESOLVED** by the City Council of the City of Seguin, Texas:

**SECTION 1.** The City Council hereby awards the bid in the amount of \$15,394,288.26 to Sterling Delaware Holding Company for the Rudeloff Road Widening and Improvement Project.

**SECTION 2.** The City Manager, Steve Parker, is authorized to execute a construction contract with Sterling Delaware Holding Company for the Rudeloff Road Improvement Project.
