**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AWARDED A BID TO M&C FONSECA CONSTRUCTION CO. INC. FOR THE CONSTRUCTION OF THE LINK ROAD WATER & WASTEWATER CAPACITY UPGRADES PROJECT TO INCLUDE VARIOUS APPURTENANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH M&C FONSECA CONSTRUCTION CO. INC.; AND DECLARING AN EFFECTIVE DATE**

**WHEREAS**, City Council previously approved an engineering services proposal for the design, bidding, and construction administration services for the Link Road Water & Wastewater Capacity Upgrades Project; and

**WHEREAS**, the above referenced project is to install approximately 26,600 linear feet of 8"-12" PVC water main; and

**WHEREAS**, to install approximately 11,800 linear feet of 24" PVC wastewater main; and

**WHEREAS**, this project will increase capacity in the wastewater collection system from the Cordova Lift Station to Link Road; and

**WHEREAS**, this project will improve service to the Navarro High School property north along State Highway 123 to Link Road continuing west to serve areas of the Springs Hill SUD CCN transfer; and

**WHEREAS**, the City solicited bids for the construction of the Link Road Water & Wastewater Capacity Upgrades Project to include various appurtenances; and

**WHEREAS**, eleven bids were received ranging from a low bid of \$8,405,431.25 to a high bid of \$13,628,716.56; and

**WHEREAS**, reference checks on projects supplied by the bidding contractors found that M&C Fonseca Construction Co. Inc. has completed projects to the satisfaction of the Owners and Engineers.

**WHEREAS**, based on the reference checks, City staff recommends accepting the low bid of \$8,405,431.25 submitted by M&C Fonseca Construction Co. Inc. plus \$844,568.75 in contingency for a total amount of \$9,250,000.00; and

**NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin, Texas:**

**Part 1.** The City Council of Seguin, Texas, hereby approves the bid submitted by M&C Fonseca Construction Co. Inc. in the amount of \$8,405,431.25 for the construction of the Link Road Water & Wastewater Capacity Upgrades Project to include various appurtenances, plus \$844,568.75 in contingency for a total amount of \$9,250,000.00.

**Part 2.** The City Manager is authorized to enter into an agreement with M&C Fonseca Construction Co. Inc., for the construction of the Link Road Water & Wastewater Capacity Upgrades Project to include various appurtenances.

**Part 3.** This Resolution is effective from and after the date of its passing.
