Main Street and CVB Director Kyle Kramm invited everyone to attend the City's 4th of July celebrations, starting with Freedom Fiesta on June 29th, a patriotic concert on June 30th, the fireworks show on July 3rd, and the flag raising ceremony and parade on July 4th. He announced that there were already 112 entries in the parade so far.

Councilmember Lievens requested increased police presence or that an engineered traffic solution be considered on south bound Hwy 46 as it approaches I-10. The closed left hand turn lane has traffic backing up and impatient drivers are using the shoulder as a lane. Next, he introduced his brother, Dr. Lievens, and reported that Dr. Lievens lives in the middle of a large stray cat population on Burgess St. He asked that Shelley Lutz with Animal Services give a presentation to City Council an update on Animal Services programs.

Golf Course General Manager Bruce Allen informed that in a response to the concern regarding the tree removal proposed by the Ross Golf Design team, the Golf Advisory Board called a special emergency meeting to review the tree removal plan. Of the 51 trees recommended for removal, the Board unanimously agreed to remove 17 trees that were marked as a safety hazard, 11 trees to accommodate the new irrigation at the lake, and the 5 trees that would interfere with the redesign of the driving range tee box and Hole #3. The Board voted to save six of the eight trees in the shade category and five of the six trees in the playability category.

Councilmember Lievens referenced Ross Design's letter regarding the City paying into a trust fund to plant trees elsewhere and asked if that was something the City was looking at doing. Mr. Allen answered yes, the City has a fund to plan new trees elsewhere but the problem is that the code requires the new trees to be irrigated, which can make maintaining them an expensive endeavor.

Deputy City Manager Rick Cortes stated that the money will get paid into a tree trust fund and after staff creates the initial plan for utilization of that fund the plan will go to City Council for consideration.

Councilmember Gaytan asks how many total trees will be removed from the golf

course and Mr. Allen answered 40. Gaytan asked how many trees would need to be planted back at the golf course to recover what is being removed. Mr. Cortes answered that they go by caliper of the tree. There are 1600 caliper inches being removed so if the City was to plant two inch trees that would be 800 trees. Next, Councilmember Gaytan asked how much money will be deposited into the tree trust fund and Mr. Allen responded that they are still trying to determine the amount, but are estimating around \$65k-\$75k. Lastly, Gaytan asked if there would be a specific plan for maximizing the tree replanting so that the funds are not spent elsewhere and Mr. Cortes confirmed there will be and that there is currently about \$30k in the fund.

City Attorney Mark Kennedy explained that Section 2306 of the Texas Government Code defines a procedural requirement that allows for local entities to consider a resolution of no objection to the project as well as gives the opportunity to have a public hearing.

City Manager Steve Parker informed that the project is a 10 acre multi-family development located north of Park West on San Antonio Ave. The developer has submitted an application to the Texas Department of Housing and Community Affairs for Non-Competitive 4% Housing Tax Credit. The development will consist of 202 apartments for individuals aged 55 and older with income equal to or less than 60% AMI. Mr. Parker stated that Seguin does not have a lot of this type of apartment stock. He introduced Carly Gast, Development Director with Kittle Property Group, Inc to answer any questions.

Councilmember Lievens asked if they are two story units and Ms. Gast confirmed that the units will be one story units. He also asked if there was a community room and she answered there is common area space, leasing office, business center, amenity center, and food pantry.

Smart Grid Solutions Manager John Saldana reminded that Clty Council approved Phase 1 of the Outage Management System on February 6, 2024. Phase 2 is crucial for successful deployment of the Outage Management System (OMS). The primary objectives of the OMS are to provide real-time electrical outage detection, real-time notification of outage status and estimated restore time for both water and electrical, dispatching crews more quickly, and provide analytics and reporting of outage events for regulatory agencies and internal management.

Mr. Saldana explained that the City received two bids and that City Staff recommends going with the higher bidder, Data Voice International in the amount of \$326,151.75 because they are the only vendor who can povide simultaneous monitoring of both electric and water services in a single application.

Councilmember Lievens asked if the communication tool could be used to communicate with residents about items in addition to the outages and Saldana confirmed that it could be used to communicate other functions as well.

Mayor Dodgen asked if there will be some kind of integration on the website and Saldana stated that it would be integrated into the website.
