Suzanne Wynn, 425 Alta Vista Terrace, stated that she attended the Drainage Project Neighborhood Meeting held on August 27th because she had questions about the Mays Creek Project. She mentioned many people attended the last Planning and Zoning meeting and asked really good questions, none of which have been addressed. She added that the Rio Verde subdivision, a rent-to-own, affordable housing development is being built off FM 725 and that she hopes that tax exemption for that development is not the exemption being discussed in closed session later this evening. She said that her neighborhood has been redesigned after the final plat, turning her cul-de-sac street into a connector to SH46 to get those additional 5,000 people living in the Rio Verde subdivision access to SH46. She declared that if the City built Rodeo Run, which is in the Master Thoroughfare Plan, then there is no reason to turn her cul-de-sac street into a connector for SH46. She said it was outrageous that they will now have that type of traffic through her neighborhood when

that was not the case when she bought her home. Additionally, she commented on the recently approved 11 acre commercial development at Gamecock and Tanglewood. She said Planning and Zoning Commission just approved a non-conforming use of chemical storage, warehouse, retail office space, water towers and a water retention tank. She asked to see what the City plans were for if the chemical storage facility is flooded and the chemicals sweep down to Arroyo Ranch. Ms. Wynn said that she was disappointed that the August 27th meeting and said she still had many questions, including the following: when will construction start and end, what is the impact on traffic, are there any plans to redirect traffic during construction, will the entrance to Voegel Elementary School be closed during construction, are there any plans to permanently close the school's entrance or exit, will there be a traffic light installed, and are there any plans to address congestion. The City is adding 12,000 more residents that will use that intersection on a daily basis. Ms. Wynn continued to ask questions related to the impact of this project on Mays Creek, traffic, the increase in property value for surrounding properties and when residents of Guadalupe Heights and Arroyo Ranch will see a copy of a MDG Rio Case V settlement agreement.

Mayor Dodgen wished Deputy City Manager Rick Cortes a Happy Birthday.

Presentation and update on TxDOT Projects in and around Seguin, Texas. - Will Locket, P.E., TxDOT Area Engineer through Melissa Reynolds, PE, Director of Engineering & Capital Projects

Indexes:

Director of Engineering and Capital Projects Melissa Reynolds introduced Will Lockett, Transportation Engineer with Texas Department of Transportation (TxDOT) to give a presentation on the status of TxDOT projects throughout Seguin. Mr. Lockett then introduced his coworker Roger Steigleder, Technical Project Manager, to answer any more technical questions related to traffic signal improvements.

Mr. Lockett informed signal improvement projects are run through the District Traffic Office. The current project cost approximately \$2.06M and is approximately 96% complete. He reminded that some of the lighting systems in Seguin date back to the 1970s. The location of the traffic light improvements are:

- SH 46 at CH Matthies Jr
- N. Kingsbury St. at N. Austin St.
- N. Kingsbury St. at Heideke St
- N. Austin St at Cedar St.
- Court St at Travis Camp, River and San Marcos St

Improvements made at each location varied, but consist of transitioning from string lights to mast lights, adding illumination, updating detection technology, pedestrian element improvements, radar vehicle detection and adding communication package to allow for off-site monitoring.

Mr. Steigleder added that there is another TxDot project on the calendar for Seguin. The project is a full traffic light rebuild at Kingsbury and Vaughn and is scheduled to start mid-October. The project is expected to take 45 working days. He mentioned there is another project at SH123 and US90 as well as SH123 at Cedar Middleton on the calendar for mid-October as well.

Mr. Lockett gave an update on the status of the I-10 Expansion Project, from FM 464 to SH-130. He informed that I-10 will be widened between FM464 and Hwy 123, but not after the SH123 Bypass. There will be a mill and inlay out to SH-130, with new bridges, ramps, frontage road, signals, and highway lighting installed. The estimated completion date for this project is Fall 2029.

Councilmember Lievens asked if the three-way stop at Flemings can be made a four-way stop to make it more safe. Mr. Lockett answered that a signal is not part of this project but that they would analyze that intersection for a fourth stop sign temporarily. Lievens asked if this highway construction will impact "Lake Hildalgo". Mrs. Reynolds answered that drainage issue is addressed with one of the upcoming GLO projects but is currently caught up in permitting challenges with TxDOT and Union Pacific.

Mayor Dodgen acknowledged that Mr. Lockett fought for Seguin to get the FM78 improvements added to this contract as it was not included in the original contract.

Mr. Lockett announced that Huber Rd under I-10 will be closed from about September 10 - October 1, 2024.

Councilmember Rangel stated that Court St from SH-46 to Austin is very rough. Mr. Lockett replied that he is trying to get a resurface for Court St and Kingsbury within the next four years, but there is no date set.

Finance Director Susan Caddell announced that two changes have occurred since the last presentation of the budget. The original budget included \$280,000 for the City's portion paid to Guadalupe County Appraisal Districts. Due to the passage of Senate Bill 2, the school districts' homestead exemptions increased, lowering the school districts' allocation of GCAD's budget. That difference had to be reallocated back to the other entities. The City's portion of this reallocation is \$16,288 so the budget for that item has been increased accordingly. In addition to that change, Mrs. Caddell informed that the City has been awarded a regional solid waste grant for \$25,000 from AACOG that requires a match from the City of \$12,5000. This will allow the City to have a hazardous waste collection event in the spring of 2025. The match for the grant will be paid out of interest earnings.

The TIA will determine if any mitigation measures are needed to ensure the roadway network can function safely and efficiently.
