On May 3, 2022 the City of Seguin received two bids for the referenced project. The bids were opened and read aloud, and a summary of the bids received is as follows:

- The total project bid amounts ranged from a low bid of \$1,372,685.00 to a high bid of \$1,548,378.50.
- The final Engineer's Estimate for this project was \$995,149.45.
- The apparent low bidder was D&S Concrete Contractors, with a total bid of \$1,372,685.00, which is approximately 38% above the Engineer's Estimate.

All responses were checked and verified for accuracy, and no errors were found in the bids. Therefore, we recommend awarding this contract to D&S Concrete Contractors.
