#### 1. Call to Order

Mayor Dodgen called the meeting to order at 5:30 p.m.

#### 2. Invocation - Mayor Donna Dodgen

*Mayor Dodgen introduced Pastor Jeremy Roy to give invocation.*

*Pastor Jeremy Roy mentioned that District 2 Councilmember Sonia Mendez passed away today before he began invocation. Pastor Roy wished peace and comfort*

*George Kostryko, a liaison with the U.S Small Business Administration Office of Disaster Recovery and Resilience, shared information on what the Small Business Administration can do for local citizens and business owners and announced that a disaster resource center will open in San Marcos.*

Councilmember Keller announced that this Friday he will have been married to Kitty Keller for 49 years. He said they have lived in Seguin since 1979 and he saluted her for putting up with him.

Councilmember Biesenbach recalled that Falling Heroes Night was postponed due to inclement field conditions but announced that it has been rescheduled for Tuesday, June 18th. Also, he wished his son Jackson good luck as he was playing in the Little League Baseball championship. Lastly, he said that he met Councilmember Sonia Mendez ten years ago playing volleyball. He said he was fortunate to get to spend time with her and to meet her children Jacob, Raquel, and Andy and that Councilmember Mendez will be greatly missed.

Mayor Dodgen said today has been a sad day but great things have happened too and explained that there are often gifts given when things like this happen. She explained that Councilmember Keller and the kind words to his wife were a gift and the proclamation that is about to be read is a gift. She also announced that Parks and Recreation Director Jack Jones placed a softball at Councilmember Mendez's place at the dais because she loved to play softball and watch her kids play.

- a. Presentation of a proclamation by Mayor Donna Dodgen to Lila Smethurst.

Mayor Dodgen and Councilmember Keller introduced Lila Smethurst and congratulated her on winning Food Network's Kids Baking Champion, Season 12. Mayor Dodgen read a proclamation declaring Tuesday, June 4, 2024 "Lila Smethurst Day" in Seguin.

Miss Smethurst thanked the City of Seguin for the recognition and thanked her mom, dad, and sister for all of their help with her baking and business. She shared how grateful she was for the experience and left a dessert for each of the councilmembers.

- b. Presentation and discussion on the creation of a downtown Tax Increment Reinvestment Zone - Kyle Kramm, Seguin Main Street & CVB Director/HPO.

Councilmember Lievens complimented Main Street and CVB Director Kyle Kramm on his constant professionalism and preparedness and thanked him for organizing a very successful walking tour of the downtown properties available.

Mr. Kramm stated that a Tax Increment Reinvestment Zone (TIRZ) allows for property tax money that is earned in the downtown to be invested back into the downtown. He reminded City Council that the funding for the creation of the TIRZ was included in budget this year. Then, he introduced Travis James with TXP, the consultants on the project.

Mr. James explained that a Tax Increment Financing (TIF) is the mechanism used to create a TIRZ. Once a reinvestment zone is created, a tax increment baseline is identified. Annually, over the life of the TIRZ, the baseline will continue to be paid to the General Fund, but the growth in revenue from additional tax increments will be paid to the TIRZ and must be used for projects inside the boundaries of the TIRZ. He

*informed that a TIRZ is not a tax rate increase and will not burden a property owner as implementation is handled through the appraisal district. Then, Mr. James gave examples of when a TIRZ is most commonly used, explained the limitation of including residential properties, announced the preliminary values of the proposed boundary map and how those values would increase if the County participated in the TIRZ, and gave a summary of the steps the City would need to take to create the TIRZ. Finally, he showed the proposed TIRZ boundaries.*

*Councilmember Gaytan asked who created the proposed boundary lines and Mr. Kramm answered it was a combination of himself, Mr. James, and Economic Development Director Josh Schneuker. Councilmember Gaytan commented that with the expectation that the County courthouse will be moved away from downtown, the County would be a great partner.*

*Mr. James informed that if the County chooses to participate, they would do so via an interlocal agreement.*

*Councilmember Lievens asked what the cons of a TIRZ. Mr. James answered that if a TIRZ is put in place and nothing happens or if you put too much money into a TIRZ that you do not have enough money elsewhere, those could be considered cons. He explained that the most important thing is to know when to use this tool instead of a different incentive tool.*

*Councilmember Gaytan announced that this is a fantastic idea. The downtown needs investing and he is in full support.*

*Mayor Dodgen proclaimed she was excited about redeveloping 2nd floor and for the potential to add fire suppression systems to the buildings.*

*Councilmember Gaytan suggested that the follow up to this agenda item be held the 2nd meeting in July instead of the first meeting in July to avoid the holiday and also asked that they be given time to review the boundaries and make changes if desired.*

*Mr. Travis answered that as long as the approval process is completed by the end of the year, then there is time. Mr. Kramm informed that he will email a copy of the presentation to councilmembers as well as a copy of the map so that they can review it and email to him any questions or suggestions for change.*

*Director of Planning and Codes Pamela Centeno informed that the City requires permits for permanent and temporary food establishments. The fees for permanent food establishments are based on the number of employees for the business. However, many retail shops in Seguin, large and small, sell prepackaged foods and do not prepare food at their establishments. Ms. Centeno stated that Staff is recommending a new permit category for retail shops that only sell prepackaged foods. The annual fee for the new permit would be \$100, versus the \$250 retail shops currently pay. Additionally, she reported that Staff is recommending a new category for temporary food establishments that operate for an extended period of time at multiple local festivals and markets. The permit would be issued for up to 180 days, with monthly inspections. Currently, multiple permits would be necessary to accommodate the 180-day period and would amount to \$300 over the 6-month period. The proposed fee for the multi-event permit is \$150.*

*Councilmember Gaytan declared that the new permit categories were a great idea and a creative way to help people sell food in Seguin.*
