Seguin Wave Pool Paint (Buy Board: 701-23)

SCOPE OF WORK:  
Buy Board- 701-23

Paint wave pool to 3' line only & splash pool

Scope of work includes high power pressure washing the entire areas that will be painted. We will then clean and etch the entire surface area, and then rinse 3 x. We will then paint the wave pool to 3' line and splash pool with Poxolon 2 (Blue Ice) --2 Coats. On the 2nd coat we will add extra sand/non-slip from the beach entry to the 3' line. The same process will be used for the Splash Pool. We can add extra sand/non-slip to the entire Splash Pool if needed.

\*\*For the slipping issue.....The only thing that we can do is add extra sand/non-slip to the beach entry area. It will eventually rub off with all of the foot traffic. Unfortunately, it is something that they will have to continually have to re do.
