- 34 people currently hospitalized at GRMC
- 22 Guadalupe County resident deaths reported by GRMC
- 7 day rolling avg for new daily admits-4 patients (last week was 7)
- 7 day rolling avg for Covid patients- 33 patients (last week was 38)

## Employee Update

**4 positive employees** - currently out or working from home.

**3 pending test results**- 1 symptomatic and out of the office; 1 asymptomatic and working from home; 1 asymptomatic and currently working.

**2 negative test results** - Both are symptomatic and are currently out of the office. Both are seeking guidance from their PCP.
