A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, ORDERING A GENERAL ELECTION TO BE HELD NOVEMBER 5, 2024 FOR THE PURPOSE OF ELECTING A MAYOR AND CITY COUNCIL MEMBERS FOR DISTRICTS ONE, TWO, FOUR AND SIX; ORDERING THAT NOTICE OF THE ELECTION BE PUBLISHED; AUTHORIZING THE CITY MANAGER TO EXECUTE A JOINT ELECTION AGREEMENT; AND DECLARING AN EFFECTIVE DATE

WHEREAS, the Seguin City Charter provides that the City shall hold elections in even numbered years on the November uniform election date and shall elect four council members each election; and

WHEREAS, the Seguin City Charter provides that every fourth year on the November uniform election date the City shall elect a mayor; and

WHEREAS, earlier this year the City Council approved a contract with Guadalupe County for conduction the election; and

WHEREAS, Guadalupe County, by contract with the City, will conduct the election including providing for early voting and election day polling places; and

WHEREAS, the attached Agreement sets out the terms for conducting the election jointly with the other entities holding an election in November.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Seguin, Texas:

SECTION 1. A general election is ordered (Exhibit 1) to be held by the City of Seguin (the “City”) at the polling places and election precincts as hereinafter designated, on November 5, 2024 from the hours of 7:00 a.m. to 7:00 p.m. Notice of the Election (Exhibit 2) will be published as required by law. This general election will be administered for the City by the Guadalupe County Elections Administrator to be held concurrently with the Seguin Independent School District Election and the Navarro Independent School District as well as the County, State and Federal elections. At this election the qualified voters of the City will elect a mayor, and at this election the qualified voters who respectfully reside in Districts One, Two, Four and Six will elect a City Council Member to represent each of those four districts.

SECTION 2. The general election will be held in accordance with the provisions of the Charter and Ordinances of the City of Seguin and the laws of the State of Texas. Candidates for Mayor, Councilmembers for Districts One, Two, Four and Six may begin filing for the office on July 20, 2024, at 8:00 a.m. The deadline for filing by candidates for the aforementioned positions is 5:00 p.m. on August 19, 2024.

SECTION 3. Early voting will be conducted at the Seguin Elections Office, 215 S. Milam St., Seguin, Texas; Elections Office Annex, 1101 Elbel Road, Schertz, TX; Cibolo Fire Station #2, 3864 Cibolo Valley Dr., Cibolo, Texas; Central Texas Technology Center, 2189 FM 758, Bldg. B Room 159, New Braunfels, Texas; Redemptive Grace Ministries, 2240 FM 725, New Braunfels, Texas; New Berlin Community Center, 8815 FM 775, New Berlin, Texas; Selma City Hall, 9375 Corporate Dr., Selma, TX;

Marion ISD Tondre Room, 500 Bulldog Lane, Marion, TX; Seguin ISD Admin Bldg, 1221 E. Kingsbury St., Seguin, TX, as follows:

SECTION 4. The polling places for both early and Election Day shall be established in accordance with the Election Services Contract, and shall be set out in the Order for Election and the Notice of Election that shall be published in accordance with the City Charter and Texas Election Codes.

SECTION 5. The Joint Election Agreement (Exhibit 3) that is attached to this Resolution is hereby approved.

SECTION 6. The City Manager, Steve Parker, is authorized to execute the Joint Election Agreement.
