Gary Vaughan, 503 S. Goodrich, Seguin, Texas, 78155; Mr. Vaughan spoke on the golf project stating he supports all that former Council member Mark Herbold said at a prior meeting. Mr. Vaughan states we are about to spend potentially about nine million dollars, Mr. Vaughan asked the city council; What are we going to do different that is going to keep this golf course around and in great shape? Mr. Vaughan passed around some photos, stating the photos show what everything looked like after it was rebuilt and photos of what it looks like today. The photos show some areas in very bad condition, bad grass, stating it is a terrible green. Mr. Vaughan states all he is asking is that this time let's do it the right way and have the right

people in place.

Javier Cuevas, 831 Jefferson, Seguin, Texas, 78155; Mr. Cuevas first wanted to commend City Manager, Steve Parker, for opening the community room at the library for those needing a warm place to be during the freeze. Mr. Cuevas states we as a community need to do more.

City Councilman Paul Gaytan, stated he wanted to thank the Martin Luther King Community for the wonderful MLK Celebration.

City Manager Steve Parker states he appreciates staff for preparing so diligently for the weather event over the holiday weekend. Also stating that the City of Seguin was looking out for our community and those in need of a place keep warm during the hard freeze. Several homeless folks were placed in hotel rooms to help keep them safe and out of the freezing weather. Mr. Parker states that our city team (Police, Fire, Public Works, Parks, and Facilities) were ready and prepared. Mr. Parker thanked all staff.

Discussion and direction to staff on potential amendment to Section 98 - 109(d)(3) to adjust the limits of Parking By Permit Area A, North Saunders Street between Medlin Street and West Court Street - Steve Parker, City Manager

The City Manager, Steve Parker stated he was opening a discussion on the parking by permit on N. Saunders Street between Medlin Street and W. Court Street. Mr. Parkers states in May and July of last year permit by parking was brought to the City Council and the first street was N. Saunders between Medlin and West Court Street, on both sides. Within the last few months, a couple of residents have come into City Hall to express their concerns, so it was brought back as a discussion with City Council tonight at the request of Mayor Donna Dodgen's; asking council if they believed this was still viable a option. Recommendations are to possibly change it to just one side of the street. We are opening it to the council for discussion, no action item.

Mayor Donna Dodgen states she did want to have a discussion regarding the permit by parking at this location, stating she was under the impression permit by parking would be on only one side of the street. Mayor states it should be on one side of the street, to keep folks from parking in front of the resident's homes.

City Council Chris Rangel concurs with Mayor Donna Dodgen, that permits by parking should be on the one side as to keep folks from parking in front of the resident and blocking driveways.

City Council Jason Biesenbach states there should be no permit by parking. Citizens should be able to park on the street. Councilman Biesenbach says to leave parking open.

City Manager, Steve Parker reminds staff that there should be no parking on the bridge.

City Engineer, Melissa stated that notifications will be sent to all the residents and business owners on the street.

City Council Paul Gaytan states that he is the one that requested the discussion on short term rentals to give citizens a chance to voice their concerns.

Dr. Bill Campaign,148 Wampum Way, Seguin, Texas 78155, Dr. Campaign says that he wanted to thank Councilman Paul Gaytan and City Council for considering an ordinance on short term rentals. Dr. Campaign states that he has a short-term rental next door to his home and another a few houses down on his street. Dr. Campaign presented a couple of example ordinances that the City of New Braunfels has adopted, and states that some of the reasons they have been adopted is there has been loss of neighborhood integrity, safety was a concern as well. Dr. Campaign states he is not opposed to short-term rentals, but it is imperative that there are ordinances for the benefit of the community and for the renters.

Renae Henze, 21 Cherry Hill, Seguin, Texas, 78155, Ms. Henze state her family bought a home in Seguin in 2019 in the Chaparral area, stating they love the neighborhood, it was quiet and well kept, and it still well kept. By 2021 three homes across from hers were sold, bought, and turned into short term rentals; stating it has been a nightmare since then. One of the homes is rented to eighteen-year-olds with a limit of twenty-eight people that can stay the night. The problems are the parties until 4:00 am, with over two hundred kids and cars causing traffic issues. Ms. Henze states her neighbor's mailbox has been backed into several times. Trash blowing everywhere, there is no consideration for the permanent residents. Ms. Henze states we need some governing of the short-term rentals.

City Councilman Paul Gaytan asked Ms. Henze about a photograph that represented over two hundred people attending a party at one of the rentals? Ms. Henze stated "yes", Councilman Gaytan asked if this was the rental property that allow eighteen-year-olds to rent it? Ms. Henze states seniors in high school could be renting this rental.

Lee Johnson, 19 Cherry Hill, Seguin, Texas, 78155, Spoke on the short-term rental at 48 Cherry Hill, States this is a safety issue. Also stating lately, the folks renting over the weekends have Mexico plates.

Beth Gatte, 1123 Burges St. Seguin, Texas, 78155, States she was kayaking on the river and saw a man with a gun who had been shooting into the river.

Sofea Burton, 138 Wampum Way, Seguin, Texas, 78155; Ms. Burton states she has a short-term rental next door to her home but has not had problems with the folks renting. Ms. Burton states she is in support of an ordinance for all short-term rentals in Seguin.

City Councilman Paul Gaytan gave a suggestion that the City Council move forward

in putting together an ordinance for short term rentals.

Mayor Donna Dodgen states she would like some data before having an ordinance put in place.

City Councilman Paul Gaytan we need to do something now, and we should look at what our neighboring cities have in place for their short-term rentals.

City Councilman Jim Lievens states he believes in data and is in favor of staff looking into this, also stating there should be a limited number of people staying at any given night.

City Manager, Steve Parker states there are some restrictions and there are other things we can do. We would make sure they have parking plans, make sure they have safety measures in place. Mr. Parker gives an example of something the City of San Marcos does, with have the rental properties register and after so many violations are not able to work as a rental property.

Mayor Donna Dodgen states that she feels that all, the City Council, City Manager, Steve Parker, and staff agree that staff will put some data together and can come back to council for more discussion.

City Councilman Bill Keller states he wants to go on record as saying hotels should provide parking for their customers. Customers should not be having to park on the street. Council man Keller states there is a lot of vacant property around Jay Road and developers will be looking. Councilman Keller states we don't want them to see all the semi-trucks parked on the street. It may influence their decisions to purchase the property for development. Councilman Keller states he is against the trucks parking there and is against parking by permit.

City Councilman Jason Biesenbach states the streets are paid for by the citizens and anyone should be able to park on the streets.

City Councilman Bill Keller states we should place no parking signs.

Jud Alexander, 318 Montwood, Seguin, Texas, 78155; states he represents his family and the vacant land surrounding Jay Rd. Mr. Alexander states they do have intentions for more commercial retail development and when that happens the street will become of more use. Mr. Alexander states if you place two eighteen wheelers on each side the street becomes a one lane road. Mr. Alexander states it is a safety

issue, the fire hydrants are not accessible at night. Mr. Alexander states he feels no parking signs should be placed. The street really should be cleared for access.

City Councilman Jason Biesenbach spoke on how eighth street has no parking signs and there are still problems with trucks parking and throwing their trash out, there needs to be more enforcement.

Director of Economic Development, Josh Schneuker spoke on they are still having some complaints on eighth street, even with the no parking signs in place. Issues with property damage and trash is still an issue.

City Attorney, Mark Kennedy stated the item will be brought back to council.
