Former City Councilmember Jett Crabb, 502 E. Wright, and Steven Berger, 209 Lone Oak, announced the First Annual Lights and Sirens Cornhole Tournament, a joint fundraising effort hosted by the Seguin Police and Fire Academy Alumni Associations to support Seguin's first responders. The event will include food trucks, a card raffle with prizes like a blackstone griddle, a silent auction, snacks and music. Ms. Crabb invited everyone to sign up a team or to consider sponsoring the event. She also informed that Police Chief Brady and Assistant Chief Suarez will play against Fire Chief Skinner and Deputy Chief Hubbard and the team not victorious would have to make a donation to the opposing sides alumni.

Paul Martin, 605 Elm Street, shared his concern with water conservation and availability, ecological literacy, and degrowth and invited everyone to attend an ecological discussion on October 2, 2024 at 2 P.M. at the Seguin Columbus Hall. He

then read an modified version of the poem "Mining the Motherload" by Andy Wilkinson.

Parks and Recreation Director Jack Jones invited everyone to attend a Community Input Meeting to discuss the Recreation Feasibility Study on Tuesday, October 29, 2024 at the Seguin Coliseum. He mentioned that snacks will be available and consultants will be onsite to help determine if a recreation center is needed in Seguin, and if so, what experiences will be most desired by the community. He announced that they are working to get the meeting streamed live as well.

Josh Bright, 2122 Goodluck Rd, informed that October 29th is also the Seguin ISD School Board Meeting and suggested that the City consider rescheduling the Community Input Meeting so that people could attend both meetings. He opined that the "buy-in" from the school district at the Community Input Meeting might be important.

Presentation by Seguin ISD on the upcoming November election. - Liz Oakes, Seguin ISD Chief Financial Officer

Indexes:

Liz Oakes, Chief Financial Officer for Seguin ISD explained how school districts across the state have been struggling financially for several years as there has been no increase to basic funding since 2019. This, in addition to inflation, has caused Seguin ISD to adopt a deficit budget of \$4M. While Seguin ISD has historically given raises, it did not give employees raises this year. The Fund Balance, which must stay at a certain level to comply with acceptable accounting practices, is nearing its minimum level. Ms. Oakes explained that the school is looking at a three part approach resolving the budget deficit over time. First, they are looking at how money is being spent and making appropriate cuts. Secondly, they are looking to increase revenue potential by bringing in programs that receive more state funding, like career and technical education (CTE). She informed that the district just hired a new CTE Director and that 82% of high school students are enrolled in at lease one CTE class. The third approach Seguin ISD is using is a Voter Approval Tax Ratification Election (VATRE) on the November 5, 2024 ballot, called Prop A.

A VATRE allows voters to approve or disapprove the tax rate adopted by the Board of Trustees. If passed, Seguin ISD will maximize the amount of state funding the district receives per dollar of local property tax collections. Proposition A provides \$2.3M of new revenue in the current fiscal year for the district's maintenance and operations budget, and is expected to provide at least as much each year after. 57% or \$1.3M of the money generated from Prop A will come from the Texas Education Agency in the form of State funding, the other \$1M will come from local property taxes. This allows Seguin to sustain and increase teacher and staff pay, and maintain student programs. Seguin ISD is one of the largest employers in Guadalupe County.

The Seguin ISD 2023 Total Tax Rate is \$1.1166. If Prop A passes, the Seguin ISD 2024 Total Tax Rate would be \$1.1028, the lowest tax rate in over 20 years and the lowest in the region. Homeowners ages 65 and over or disabled who apply for and receive an exemption, will not have an increase over their frozen dollar amount. Their taxes are frozen at the dollar amount paid when their exemption was filed. Veterans who have a 100% disability rating or surviving spouses of a member of the U.S. Armed Services killed in the line of duty would not see an increase in taxes. Ms. Oakes introduced Seguin ISD Superintendent Veronica Vijil, Director of Communications Emily Allen, and Chief of Students Services Nikki Bittings. She also introduced Seguin ISD Board of Trustee President Alejandro Guerra, Secretary Linda Duncan and Trustee Joshua Bright. Ms. Duncan and. Mr. Bright encouraged everyone to get out and vote for Prop A.

Presentation of the Strategic Water Supply Plan and the development of water supplies to meet the City's future water needs. - Timothy J. Howe, Director - Water / Wastewater Utilities

Indexes:

Director of Water and Wastewater Tim Howe reminded that the initial strategic water supply plan, including projections for years 2025 through 2080, was presented to City Council in May 2023. At that time, the City had just received its Bed and Banks permit, allowing the City to divert up to 9,200 acre feet of ground water. Further analysis of said permit calculated a firm supply for this source, which is what the amount expected to receive from that permit in time of extreme drought. Mr. Howe introduced Darren Thompson with HDR Engineering, Inc. to present their updated strategic water supply plan.

Mr. Thompson explained that the ability to divert water is contingent on meeting downstream subsistence flow. The current demand is less than 10,000 acre feet per year and up to 15,000 acre feet per year in extreme drought conditions. The planned yield long-term for the Bed and Banks permit is 12,000 - 20,000 acre feet per year. The challenges of relying on the Bed and Banks supply is that while it is available during normal weather conditions, it is severely limited during extended periods of drought. Mr. Thompson stated that the City has an existing diverse water supply portfolio that has the ability to meet future growth needs during normal weather conditions and gave the details of some alternate water supplies that the City has access to if needed.

Mr. Howe gave an overview of Guadalupe-Blanco River Authority's (GBRA)
WaterSECURE project, the largest water project in the Guadalupe Basin. He explained

that the cost of water per acre foot is significantly higher that the other sources utilized by the City as the City would have to share the cost in building the pipeline.

City Manager Steve Parker stated that the challenge with this project is that the City wouldn't need to water for many years to come, but the burden of debt would fall on existing customers. Due to the cost implications, several other entities have backed out of the project.

Mayor Dodgen asked if there are other options for the City to acquire water. Mr. Howe answered that the City hasn't been approached recently, but there was an opportunity presented awhile back for the City to acquire 1,000 acre feet that may still be an opportunity.

Councilmember Gaytan asked if he thought participating in GBRA's WaterSECURE project was necessary and Mr. Howe responded that the portfolio the City has now is sufficient and he would recommend developing the opportunities that cost the City the least.

Mayor Dodgen informed that she and Mr. Howe sit on a task force for the federal government that looks to see what can be done for this region and water. Mr. Howe has shared his expertise on how Seguin has taken steps to ensure sufficient water through a high growth period.

Mr. Parker added that this project is a priority for the governor's office because it is needed to make the projected economic development efforts in Texas come to fruition.

Councilmember Gaytan suggested that the City opt out of the GBRA WaterSECURE project and a consensus among council was given.

Director of Human Resources Kristy Lehnert reported that Mr. Brandon Debar, the City's benefit consultant with Gallagher, was able to negotiate from a 20% increase to a 3.5% increase for premiums. This marks three years in a row in which the City has had favorable renewal for Health Insurance.

This year, in addition to the PPO plan, the City will also offer a second health plan, a H.S.A. plan. An H.S.A plan has a higher deductible but lower monthly premium. The City will cover the cost of the employee only coverage in premiums for medical, dental and life insurance for all of its employees. In addition, if an employee elects to change their Employee Only health coverage plan this enrollment year from the PPO plan to the H.S.A. plan, the City will contribute \$40.00 per pay period to the employee's health savings account. Additionally, Staff is proposing that the City continue to contribute 25% on dependent premiums for either the PPO plan or the H.S.A plan.

Director of Water and Wastewater Utilities Tim Howe informed that the Crossroads Boulevard Lift Station Project decommissions the existing Crossroads lift station build a new Crossroads lift station with adequate capacity to meet future demand and comply with all State design criteria related to lift stations. He reported that the City received six sealed bids. The total bid amounts ranged from \$1,814,338.79 to \$2,4449,884.
