- Has to be spent on eligible Covid-19 related expenses



## Open Seguin Outreach:

# OPEN SEGUIN

City officials will begin Phase I to Open Seguin beginning Friday, May 1, 2020.

The City is following a three-phase plan announced by Texas Governor Greg Abbott on April 27 to safely and strategically open Texas while minimizing the spread of COVID-19.

Under Phase I, certain services and activities are allowed to open with limited occupancy, and the Texas Department of State Health Services (DSHS) is issuing minimum standard health protocols for all businesses and individuals to follow.

Gov. Abbott issued the following three Executive Orders relating to the [Open Texas](#) plan in response to the COVID-19 pandemic.

[By way of Executive Order \(GA-18\)](#), all retail stores, restaurants, movie theaters and malls are permitted to reopen on Friday, May 1. These services must limit their capacity to 25 percent of their listed occupancy. Within shopping malls, the food-court dining areas, play areas and interactive displays and settings must remain closed.
