AN ORDINANCE OF THE SEGUIN CITY COUNCIL AMENDING THE SEGUIN CODE OF ORDINANCES, CHAPTER 98, VEHICLES AND STREETS, SECTION 65, SPEED LIMITS ON SPECIFIC STREETS, TO EXTEND THE SCHOOL ZONE ON KINGSBURY STREET (U.S. HIGHWAY 90) AND ON COURT STREET (U.S. HIGHWAY 90A) FOR THE BRIESEMEISTER MIDDLE SCHOOL; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR PUBLICATION OF THIS ORDINANCE; AND AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE FOR SUBMISSION AS A SUPPLEMENT TO THE CODE OF ORDINANCES.

WHEREAS, the Texas Department of Transportation conducted an engineering and traffic study in the area of Briesemeister Middle School; and

WHEREAS, the results of the engineering study indicated that the school zone on both sides of Briesemeister Middle School should be extended; and

WHEREAS, the City Engineer concurs thereby recommends extending the existing school zone.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin, Texas:

SECTION 1. The Seguin Code of Ordinances, Chapter 98, Traffic and Vehicles, Article III, Operation of Vehicles Generally, Section 65, Same- Specific Streets, Subsection (b) Designated speeds up to 60 mph, is hereby amended only as to the subsection numbers listed as follows (the remainder being unchanged) (underlining indicates added text, ~~strikethrough~~ indicates deleted text):

(1) U.S. Highway 90, also known as Kingsbury Street, from the west city limits northeasterly and easterly to the east city limits:

- a.From west city limits northeasterly a distance of 1.05 miles 55 mph
- b.From a point 1.05 miles east of west city limits to Prexy Drive 50 mph
- c.From Lawson Street to Eighth Street 45 mph
- d.From Eighth Street to Heideke Street 35 mph
- e.From Heideke Street to Hummingbird Lane 35 mph
- f.From Hummingbird Lane to mile post 3.938 45 mph
- g.From mile post 3.938 to the east city limits line 55 mph
- h.MP 20.000 to MP 20.184 55 mph
- i.MP 22.129 to MP 23.142 50 mph
- j.MP 1.000 to MP 1.723 45 mph

Except that for a distance of 0.283 miles from just east of Governor Ireland Park (MP 1.000 ~~1.369~~) to just ~~west~~ east of SH 46 (MP 1.723 ~~1.652~~) the speed limit shall be 30 mph when so signed for school crossing.

(4) U.S. Highway 90A, also known as Court Street, from the west city limits easterly to the east city limits:

- a. From the west city limits easterly to Short Street 45 mph
- b. From Short Street to Goodrich Street 35 mph
- c. From Goodrich Street to Bauer Street 30 mph
- d. From Bauer Street to King Street 35 mph
- e. From King Street to Preston Drive 35 mph
- f. From Preston Drive to McCullough Boulevard 45 mph
- g. From McCullough Boulevard to east city limits 55 mph

Except that for a distance of 1.338 miles from just east of Lakeview Drive (MP 10.000) to Short Avenue (MP 11.338) the speed limit shall be 30 mph when so signed for school crossing.

SECTION 2. The City's Public Works Director is hereby authorized to place school zone signage in accordance with this Ordinance.

SECTION 3. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.

SECTION 4. City staff is authorized to prepare this Ordinance for submission as a supplement to the Seguin Code of Ordinances

SECTION 5. In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following passage on second reading and shall be published in a newspaper of general circulation.
