- The City of Seguin has budgeted up to \$700,000 for a new playground at the park similar to Bauer Park and Max Starcke Park.
- Based on public comments, there is an interest in improving local park infrastructure in the community.



Summary of Public Comment

During public comment at the Seguin City Council Meeting on November 19, 2024, a few representatives from the Seguin Youth Sports League emphasized the importance Manuel C. Castilla Park plays for youth development in the community. The community members shared that both youth and parents are eager to contribute their time and effort to improve the park's infrastructure at Manuel C. Castilla park. This included adding new football fields and other enhancements to support youth programs such as the Seguin Youth Sports League, Seguin Little League, and other community-based organizations that utilize the space.






