Subject: Investment Report for Quarter Ended September 30, 2020

Attached you will find the investment report for the quarter ended September 30, 2020. The investments range from agency and discount notes to the City pool accounts and bank accounts. All investments are allowed within the City of Seguin's Investment Policy. Average interest rates have decreased since last quarter by .4585%.

The total of all investments decreased from June 30 to September 30 by \$3,882,599. We are spending down the bond funds we received in February of this year. Interest earnings decreased from the quarter ended June 30, 2020 by \$110,821. Interest rates have decreased by 1.3141% from September 30, 2019 along with interest earnings by \$412,905. The total of all investments increased by \$9,603,408 from September 30, 2019.
