Insertion Valve Kit and Hydraulic Power Pack Bid Tabulation

Water and Waste Water Director Tim Howe explained that an insertion valve kit and small hydraulic power pack unit will allow his department to leverage technology to improve customer service as it will allow them to install a waterline while it is under pressure. The City received two bids for this equipment. City Staff recommended award to Advanced Valve Technologies who submitted the low bid of \$75,925.61. Mr. Howe stated that this equipment was approved in the FY24 Utilities Capital Equipment budget and is funded using Utility Fund Balance.

Mr. Howe explained that by approving the insertion valve kit and hydraulic power pack unit purchase two agenda items ago, the purchase of various sized valves used with that specific equipment is necessary. Currently, when there is a water leak about 40 valves have to be closed, impacting many customers. This equipment will allow the

insertion of a valve near the leak to lower the amount of valves needing to be closed, lessening the number of residents impacted when a leak happens.

Purchasing Manager Ashley Bruns stated that bids were solicited for an annual contract to provide the water treatment chemical liquid aluminum sulfate for use by the Water Utilities Department. Five bids were received and Staff recommends award to Univar USA, who submitted the lowest bid of 0.101 cents per pound. The annual estimated cost is approximately \$77,568 and funding for this expense is included in the Water Utilities' operating budget.

Assistant Director of Engineering & Capital Projects Jennifer Shortess reminded that City Council requested Staff amend Segion 98-97 of the Code of Ordinances to designate curb loading zones. She explained that designating specific areas as curb loading zones will help with enforcement. While 3 of the 4 proposed locations already have curb loading zone signage, it cannot be enforced without being adopted by ordinance.

Councilmember Keller asked if a loading time limit is stated on the sign and Ms. Shortess responded no, there is not a time limit for loading on the sign.

Councilmember Rangel asked if it will be loading/unloading only from Mountain to Bowie and she clarified where the curb loading zones begin and end at Saegert.
