

**AN ORDINANCE AMENDING THE ZONING ORDINANCE
NUMBER 884 OF THE CITY OF SEGUIN, TEXAS, TO REZONE THREE
PROPERTIES LOCATED AT 402 SPRINGS ST., LOTS 6-9 OF BLOCK 8, LOTS 5-10
OF BLOCK 9, AND LOTS 1-10 OF BLOCK 10, SPRING HILL ADDITION #2, APPROX.
11.64 ACRES, PROPERTY IDS 42333, 42341, 42342 (ZC 21-15)**

WHEREAS, the property located at 402 Springs St., Lots 6-9 of Block 8, Lots 5-10 of Block 9, and Lots 1-10 of Block 10, Spring Hill Addition #2, approx. 11.64 acres, Property IDs 42333, 42341, 42342, more fully described in Exhibit A attached hereto and incorporated herein for all purposes (hereinafter "Property") is currently zoned as 'Single-Family Residential' (R-1); and

WHEREAS, the City of Seguin has determined that the designation of said property from 'Single-Family Residential' (R-1) to 'Agricultural-Ranch' (A-R) is more appropriate for the existing land use; and

WHEREAS, the Planning and Zoning Commission of the City of Seguin has previously considered the request following notification to surrounding property owners and a public hearing as required by law; and

WHEREAS, the Planning and Zoning Commission has recommended that the application for change of designation to 'Agricultural-Ranch' (A-R) be approved; and

WHEREAS, the City Council has received the report of the Planning and Zoning Commission and conducted a public hearing thereon as required by law; and

WHEREAS, the City Council has considered the report of the Planning and Zoning Commission and the evidence and testimony of the property owner and surrounding property owners;

THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin, Texas, as follows:

1. That the highest and best use of the property located at 402 Springs St., Lot 3, Block 305, Spring Hill Addition #2, approx.. 11.64 acres, Property ID 42333, 42341, 42342, more fully described in Exhibit A attached hereto and incorporated herein for all purposes (hereinafter "Property") is currently zoned as 'Single-Family Residential' (R-1);
2. Ordinance Number 884 is hereby amended by changing the zoning designation for said property from 'Single-Family Residential' (R-1) to 'Agricultural-Ranch' (A-R);
and
3. The Planning and Zoning Director of the City of Seguin is hereby directed to reflect the herein described changes on the zoning map of the City.
