RESOLUTION OF THE CITY OF SEGUIN, TEXAS HEREINAFTER REFERRED TO AS "APPLICANT", DESIGNATING CERTAIN OFFICIALS AS BEING RESPONSIBLE FOR, ACTING FOR, AND ON BEHALF OF THE "APPLICANT" IN DEALING WITH THE ECONOMIC DEVELOPMENT ADMINISTRATION, HEREINAFTER REFERRED TO AS "EDA", FOR THE PURPOSE OF REQUESTING FEDERAL ASSISTANCE FOR AN AREA OF SUBSTANTIAL ECONOMIC DISTRESS THROUGH THE EDA PROGRAM, HEREINAFTER REFERRED TO AS THE "PROGRAM"; CERTIFYING THAT THE "APPLICANT" IS ELIGIBLE TO RECEIVE PROGRAM ASSISTANCE; CERTIFYING THAT THE "APPLICANT" MATCHING SHARE IS READILY AVAILABLE; AND COMMITTING THE CITY TO THE PROPOSED INFRASTRUCTURE IMPROVEMENTS

**WHEREAS**, the Federal Legislature has approved the "Program" for the purposes of allowing the political subdivisions of the States to participate in the Program; and

WHEREAS, the "Applicant" is fully eligible to receive assistance under the "Program"; and

WHEREAS, the "Applicant" has determined that the installation of the Infrastructure Improvements known as the 8<sup>th</sup> Street Extension, is in the best interest of the City of Seguin and will serve the legitimate public purpose of economic development; and

WHEREAS, the "Applicant" has determined that the economic activity generated from this project will positively impact the City economy, overall, which has been adversely affected by the COVID-19 disaster; and

**WHEREAS**, the "Applicant" has entered into a Memorandum of Understanding, the "MOU", with the Seguin Economic Development Corporation (SEDC), for support for the "Program"; and

**WHEREAS**, the City of Seguin is submitting a grant application for an estimated \$1,079,511, with a City cost share of an estimated \$215,902 (20%); and

**WHEREAS**, the City of Seguin has previously authorized the City Manager to apply for, accept, reject, alter, or terminate a grant on behalf of the applicant agency.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS:

**SECTION 1**: That the "Applicant" hereby certifies that they are eligible to receive assistance under the "Program".

**SECTION 2**: That the "Applicant" hereby certifies that the "Applicant's" matching share for this application is readily available at this time.

**SECTION 3**: That the "Applicant" hereby authorizes and directs its City Manager to act for the "Applicant" in dealing with the "EDA" for the purpose of the "Program" and is hereby officially designated as the representative.

**SECTION 4**: The "Applicant" hereby specifically authorizes the official to make application to the "EDA" concerning the site to be known as the "8<sup>th</sup> Street Extension" in the City of Seguin for use as commercial and industrial development.

SECTION 5: This Resolution shall be in full force and effect immediately from and after its passage.
