5. **Hearing of Residents:**

Carlos De La Cruz, 21502 Fox Park Lodge, San Antonio, announced that he was running for Congress. He said that before opening a kick boxing gym in San Antonio, he served in the military for twenty years. He also said that he wants to address what is happening with our young people because if we keep ignoring this crisis we won't have much of an economy anymore. He stated that he has personally seen the difference that discipline, faith and mentorship can makes and wants to be sure everyone knows that their life matters, Jesus loves them, and their nation needs them.

Police Chief Jason Brady invited everyone to attend their annual trunk or treat on College street on Halloween night from 6-8PM. He also reminded that the Police Department is accepting candy donations.

Fire Chief Dale Skinner informed that October is National Fire Prevention Month. He invited everyone to attend their annual open house on Halloween night at the Fire Station on Elm Street. He said that they will do apparatus tours and hand out candy and hot dogs. Chief Skinner introduced Project Squirrel, the mascot for the project is named Smokey. He said his department purchased 100 squirrel stuffed animals to give out to children who are involved in an emotional crisis. In order to keep that program going, they started selling them to the public for \$20 each, which pays for two so the idea is that they buy one for themselves and donate one. Squirrels can be purchased at Main Street, during Pecan Fest, and on the alumni association's website.

Parks and Recreation Director Jack Jones announced that the new public bathroom

building downtown will be open on Friday, in time for Pecan Fest. Main Street and Destination Director Blaire Friar invited everyone to attend the 20th annual Pecan Fest. She said that they will have over 18 different food trucks, a food truck throw down, and a Kidzone this year. Additionally, there will be 140 vendors and live entertainment. She also reminded that the Big Red Barn has activities there as well as the Wilson Pottery Show will be held at the Sebastopol House. She informed that there will be a shuttle running to all three locations. Also, she announced that Sunday is the Riverside Cemetery Tours, plugged the www.Seguingonuts.com website, and invited everyone to attend the annual Hats Off to Juan Seguin Pub Crawl.

Councilmember Biesenbach wished his wife Jackie a Happy Anniversary and an early Happy Birthday. He invited everyone to the Halloween event on College Street and said it looks like scene out of a movie. He reiterated that the Police Department is accepting candy donations and that Project Squirrel is an amazing project. He promoted the 2nd annual Lights and Sirens Cornhole Tournament scheduled for November 15th at 10am and encouraged everyone to participate or at least come watch the exhibition match between the two Chiefs.

Councilmember Carlsson thanked the first responders for their excellent work recently and said that his interactions have been with those who lead by example, set the bar high, and are doing a very good job. He said he appreciates everybody's efforts for the State of the City event but he encourages residents to get out there and engage with the leaders of the community.

Mayor Dodgen announced that early voting has begun and will be available through October 31st. She also invited everyone to attend the Pistols and Petticoats fundraiser and announced that GRMC had a big articile in Modern Healthcare magazine and was listed as one of the best places to work. She informed that Sunday is the 25th dedication of the Juan Seguin Statue and will be celebrating at the Seguin Coliseum from 11am-2pm. She informed that she was dressed in cow print overalls because the ribbon cutting for Chic-fil-A was this morning and the grand opening will be on Thursday morning. Also, she announced that Academy will open on November 2nd.

6. Presentation

a. 25-415 Recognition of TxDot Area Engineer Will Lockett upon his retirement. Donna Dodgen, Mayor

Mayor Dodgen informed that Mr. Will Lockett has been retired from Texas Department of Transportation for a few months now, but has been traveling and having a lot of fun so we are recognizing him now. She said that she appreciates everything that Mr. Lockett has done to advocate for Seguin and congratulated him for his 27 years of dedicated service to TxDOT. She said he always has been and always will be a friend to Seguin. She wished him well in his retirement.

Mr. Locket commented that he was grateful for the recognition but also for the great relationship and partnership that he had with the City of Seguin throughout his tenure.

b. <u>25-612</u> Recognition of Bobby Hyatt, Electric Superintendent, upon his retirement.
 - Donna Dodgen, Mayor

City Manager Steve Parkers said on behalf the City and staff, he wanted to congratulate Bobby Hyatt on his retirement. He said that Bobby is the kind of guy that creates the great culture around here, with pride and passion for what he does. Bobby

has been a big part of the Seguin family for 14 years and is always one of the first ones to step up and be part of the group that led. Bobby leaving will leave a hard hole to fill. Mr. Parker said that Mr. Hyatt's team and managers have a tremendous amount of respect for him and the door is always open for him to come back. Mr. Parker said that Bobby is a great example of what we want a Seguin teammember to be like.

Mr. Parker informed that Bobby began working for the City of Seguin as a Heavy Equipment Operator in the Water Wastewater Department on September 6, 2011. On October 1, 2012, Bobby promoted into the Electric Department as Apprentice. He later moved into an Apprentice III on September 14, 2014, and then an Apprentice IV on October 11, 2015. On September 25, 2016, Bobby promoted into a Journeyman/Lineworker with the Electric Department. A little less than a year later, on August 28, 2017, he became a Crew Leader. Most recently on January 19, 2025, he promoted to an Electric Superintendent. Bobby will retire from the City of Seguin on October 30, 2025, with a total of 14 years and 1 months of service. Mr. Parker congratulated Bobby and wished him a Happy Retirement.

Mayor Dodgen congratulated Bobby Hyatt on his retirement and read a certificate thanking him for his years of service to the City of Seguin and wishing him well in his retirement. She also told a story about how Bobby went out of his way to catch a bird that was in distress years ago because he knew it was upsetting to her. She shared how much it meant to her that he took care of the bird and reiterated that he was always one that would take care of things.

Manager of Electric Utility Freddy King declared that Bobby will be truly missed but that he continuing to work to keep lineman safe. He presented Bobby with a custom sign as a token of the department's appreciation for Hyatt's years of service.

and changed the purchasing thresholds so that purchases between \$50,000 and \$100,000 needs approval from the SEDC Board of Directors and any purchase over \$100,000 needs both SEDC Board and City Council approval. Mr. Schneuker informed that the SEDC approved the proposed Bylaw amendments unanimously at their last meeting.

Director of Public Works Adam Rossing informed that this contract provides a stopgap solution until a dedicated in-house concrete crew is established. It ensures critical infrastructure needs are met in the interim without delay. He explained that an IDIQ contract allows the City to address multiple small- to medium-scale concrete projects quickly and efficiently without going through a separate procurement process each time. This flexibility ensures we can respond to citizen requests, safety issues, and infrastructure needs in a timely manner. This contract would primarily support Public Works but would also be structured to allow other City departments to utilize it when needed.

Councilmember Carlsson asked if the City has executed an IDIQ contract before and Mr. Rossing answered not for concrete and not with Sullivan.

Councilmember Lievens commented that this is very innovative and creative and will help the City respond to concrete needs faster.

City Manager Steve Parker said that this will help the City maintain its concerete until the City can have an in-house crew for concrete. He informed City Council that Mr. Rossing is currently working on a sidewalk plan to determine what sidewalks are priority.
