### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AWARDING A BID TO GUERRA UNDERGROUND, LLC FOR THE CONSTRUCTION OF THE GERONIMO CREEK WWTP 48" HDPE TREATED EFFLUENT PIPELINE PROJECT TO INCLUDE VARIOUS APPURTENANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH GUERRA UNDERGROUND, LLC; AND DECLARING AN EFFECTIVE DATE

**WHEREAS**, the City Council previously approved an engineering services proposal for the design, bidding, and construction phase services for the Geronimo Creek Wastewater Treatment Plant (WWTP) Expansion which includes the upsizing of the existing 24" treated effluent line; and

**WHEREAS**, the above referenced project is to install approximately 3,800 linear feet of 48" HDPE treated effluent pipe and to remove and replace the existing 24" RCP pipe with all other necessary appurtenances; and

WHEREAS, the above referenced project will have the anticipated capacity of the expanded Geronimo Creek WWTP; and

**WHEREAS**, the City solicited bids for the construction of the Geronimo Creek WWTP 48" HDPE Treated Effluent Pipeline Project to include various appurtenances; and

WHEREAS, nine bids were received ranging from a low bid of \$3,070,881.57 to a high bid of \$6,477,539.03; and

**WHEREAS**, reference checks on projects supplied by the bidding contractors found that Guerra Underground, LLC has completed projects to the satisfaction of the Owners and Engineers.

**WHEREAS**, based on the reference checks, City staff recommends accepting the low bid of \$3,070,881.57 submitted by Guerra Underground, LLC plus \$329,118.43 in contingency for a not to exceed the amount of \$3,400,000.00; and

#### NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin, Texas:

**Part 1.** The City Council of Seguin, Texas, hereby approves the bid submitted by Guerra Underground, LLC in the amount of \$3,070,881.57 for the construction of the Geronimo Creek WWTP 48" HDPE Treated Effluent Pipeline Project to include various appurtenances, plus \$329,118.43 in contingency for a not to exceed amount of \$3,400,000.00.

**Part 2.** The City Manager is authorized to enter into an agreement with Guerra Underground, LLC, for the construction of the Geronimo Creek WWTP 48" HDPE Treated Effluent Pipeline Project to include various appurtenances.

Part 3. This Resolution is effective from and after the date of its passing.
