## STATE OF TEXAS

A RESOLUTION OF THE CITY COUNCIL OF SEGUIN, TEXAS AWARDING A BID TO PLW WATERWORKS, LLC FOR THE CONSTRUCTION OF THE GERONIMO CREEK WASTEWATER TREATMENT PLANT EXPANSION, THE WALNUT BRANCH SANITARY SEWER LIFT STATION, THE ABANDONMENT OF THE WALNUT BRANCH WASTEWATER TREATMENT PLANT, AND THE INSTALLATION OF FIBER OPTIC CABLE TO INCLUDE COMPLETE PROJECT STARTUP; AUTOHORINZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH PLW WATERWORKS LLC; AND DECLARING AN EFFECTIVE DATE

WHEREAS, due to growth in wastewater customers and TCEQ regulations the City Council previously approved a project to expand the treatment capacity of the Geronimo Creek Wastewater Treatment Plant; and

WHEREAS, the City solicited bids for the construction of the Geronimo Creek Wastewater Treatment Plant expansion, the Walnut Branch sanitary sewer lift station, the abandonment of the Walnut Branch Wastewater Treatment Plant, and the installation of fiber optic cable to include complete project startup; and

**WHEREAS**, three bids were received ranging from a low bid of \$179,584,530.38 to a high bid of \$199,448,342.76; and

**WHEREAS,** reference checks on projects supplied by the bidding contractors found that PLW Waterworks, LLC has completed projects to the satisfaction of the Owners and Engineers.

**WHEREAS**, based on the reference checks, City staff recommends accepting the low bid of \$179,584,530.38 submitted by PLW Waterworks LLC; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Seguin, Texas:

- Part 1. The City Council of Seguin, Texas hereby approves the bid submitted by PLW Waterworks LLC, in the amount of \$179,584,530.38 for the construction of the Geronimo Creek Wastewater Treatment Plant expansion, the Walnut Branch sanitary sewer lift station, the abandonment of the Walnut Branch Wastewater Treatment Plant, and the installation of fiber optic cable to include complete project startup.
- Part 2. The city manager is authorized to enter into an agreement with PLW Waterworks LLC, for the construction of the Geronimo Creek Wastewater Treatment Plant expansion, the Walnut Branch sanitary sewer lift station, the abandonment of the Walnut Branch Wastewater Treatment Plant, and the installation of fiber optic cable to include complete project startup.

Part 3. This Resolution is effective from and after the date of its passing.
