This group of individuals represent the single-family residences around the County Club Subdivision. Concern is traffic, it is a two lane road, at least ten accidents over the years. Excessive speeding, safety, duplex's will create more traffic within the area. People who live on Country Club Drive are concerned about getting out of their driveways now. Valuations are going to be impacted.

Others addressed the City Council stating that Drainage is the largest concern. To the area west, less than one-tenth of a mile is an area that considered in the floodway, and even closer it is in the 100-year flood plain. The property in discussion does not show

to be in the floodplain. To the south is Mayes Creek which is now having much greater water flowing through it due to the increased upstream flow from Arroyo Ranch and downstream is Country Club Estates. The two large rainfalls recently have shown how dangerous the Arroyo Ranch run-off area is getting, and no remedies. Every time city crews have had to barricade a low water crossing on River Oak Drive near FM 725. Additionally, this is only one of two exits out of the area, Guadalupe River Drive has a low bridge crossing near its exit to Sutherland Springs Road. They cannot see how City Council can change from Single-Family to high density, without first addressing the drainage issues first. We ask the City Council to ask staff to make drainage issues a high priority in the rezoning process.

Mr. Zamora stated he was actually in favor of the duplex's. He further stated that the proposal is to build 54 duplex homes, but this would be less number of single-family homes.

Mr. Michael Schomer, owner of the property and developer wanted to clear up some misinformation. He said he can build 31 duplex lots or 56 single family residences. Not one of the neighbors within his HOA spoke to him about the plans.

Council Member Jeremy Roy asked the owner/developer if he intended to develop this property whether it is rezoned or not and if he was going to build Affordable Housing units? Mr. Schomer said yes he will be developing this property. He will build a retention pond so that the water will flow into Mayes Creek and no he is not building Affordable Housing or Low-Income Housing.

The public hearing was recessed and the regular meeting reconvened.

Council Member Chris Aviles asked Pamela Centeno if there was a valuation of what the impact would do to the single-family neighborhood or was there a traffic impact analysis done? Ms. Centeno said that they are only looking at the zoning issues. Some HOA's have deed restrictions.

City Manager Steve Parker reminded City Council that we have a 38.6 million grant received from the Federal Government. The Chaparral area, including River Oak Dr and Sutherland Springs Rd, is targeted for a drainage analysis and design phase, and then it would be put out to bid. The developer would be required to install sidewalks as that is a part of the city ordinances now.

Council Member Mark Herbold asked if we know the percentage of multi-family units that are in this area and remember that duplex units all look the same where as single-family units are more custom. Ms. Centeno said that she did not know what percentage of multi-family units are in this area.

Council Member Monica Carter asked how soon will the 38.6 million be used for drainage and could any of the funds be used for speed bumps. City Manager Steve Parker said that the grant is only for drainage and plans are in design phase and then will go out for bid. This process could take as much as 12 to 18 months.
