## STATE OF TEXAS

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 102, UTILITIES, ARTICLE II, ELECTRICTY, TO ESTABLISH NEW RATES; PROVIDING FOR A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE, AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES.

**WHEREAS**, the proposed changes in electric rate are necessary to provide better services to the City's rate payers and to pay for improvements to the electric distribution system; and

**WHEREAS,** the rates for "outside the city" are being eliminated because the city limits now encompass the electric utilities entire certificated area; and

**WHEREAS**, existing annual membership holders, both resident and non-resident, can continue to renew their memberships as long as there are no gaps in said membership.

**NOW THEREFORE BE IT ORDAINED** by the City Council of Seguin, Texas:

**Section 1.** Appendix C – Fee Schedule, Chapter 102, Utilities, Article II, of the Seguin Code of Ordinances the City of Seguin, Texas is hereby amended as follows (<u>underlining</u> indicates added text, strikethrough indicates deleted text):
