**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS,  
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE  
EXCLUSIVE FRANCHISE AGREEMENT FOR RESIDENTIAL SOLID WASTE  
COLLECTION WITH WASTE CONNECTIONS LONE STAR, INC. TO ADD  
HOUSEHOLD HAZARDOUS WASTE (HHW) SERVICES; PROVIDING FOR A  
MONTHLY HHW SERVICE CHARGE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Seguin, Texas (“City”) and Waste Connections Lone Star, Inc. (“Waste Connections”) are parties to an Exclusive Franchise Agreement for the Collection, Hauling, and Disposal of Municipal and Residential Solid Waste within the City (the “Agreement”); and

**WHEREAS**, the City Council desires to enhance environmental protection and public safety by providing residents with a safe and compliant method for disposal of household-generated hazardous waste; and

**WHEREAS**, Waste Connections has proposed the addition of Household Hazardous Waste (“HHW”) services for single-family residential units within the City, to be provided as part of the existing residential solid waste program; and

**WHEREAS**, Waste Connections will provide HHW services directly or through a licensed and insured subcontractor, in compliance with all applicable federal, state, and local laws and regulations; and

**WHEREAS**, the proposed amendment to the Agreement would add a monthly HHW service charge of \$1.50 per residential household, billed in the same manner as existing residential solid waste charges; and

**WHEREAS**, the HHW service is proposed to commence on March 1, 2026; and

**WHEREAS**, the City Council finds that the amendment to the Agreement is in the best interest of the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, THAT:**

1. The City Council hereby approves an amendment to the Exclusive Franchise Agreement with Waste Connections Lone Star, Inc. to add Household Hazardous Waste (HHW) services for single-family residential units within the City of Seguin. The City Council hereby approves an amendment to the Exclusive Franchise Agreement with Waste Connections Lone Star, Inc. to add Household Hazardous Waste (HHW) services for single-family residential units within the City of Seguin. The amendment is attached hereto and incorporated herein as **Exhibit A**.
2. The amendment shall provide for the collection, handling, and disposal of household-generated hazardous waste only, and shall exclude commercial, industrial, medical, radioactive, explosive, and other prohibited materials, all in accordance with applicable laws and regulations.
3. The amendment shall establish a monthly HHW service charge of \$1.50 per residential household, to be billed in the same manner and cadence as existing residential solid waste charges and subject to applicable taxes, surcharges, and adjustments as provided in the Agreement.

4. HHW services authorized by this resolution shall commence on March, 2026 The subcontractor agreement between Waste Connections and HHW Solutions is structured to run concurrently with the City's existing franchise agreement, with an initial term through September 2029.
5. The City Manager is hereby authorized to execute the amendment to the Exclusive Franchise Agreement with Waste Connections Lone Star, Inc., and any related documents necessary to implement HHW services, in a form approved by the City Attorney.
6. If any section, subsection, sentence, clause, or phrase of this resolution is for any reason held to be invalid, unconstitutional, or unenforceable, such decision shall not affect the validity of the remaining portions of this resolution. The City Council hereby declares that it would have adopted this resolution, and each section, subsection, sentence, clause, and phrase thereof, irrespective of the fact that any one or more portions may be declared invalid.
7. This resolution shall take effect immediately upon its passage and adoption.
