Mayor Dodgen announced that Councilmember-Elect John Carlsson is attending the meeting remotely as he is in Norway for business.

Eddie Davila, 1843 Eastwood Dr., introduced his grandson Austin Castilleja. Austin showed City Council his Superbowl ring for the 2023 Pee-Wee CFPO Football League and a trophy from the Patriot Bowl this last Saturday. Mr. Davila informed that Austin's team practices at Manuel C. Castilla Park and he had overheard that there is money allocated this budget year for the park. Mr. Davila opined that the fields are an essential resource for youth development and should be safe and usable for the children to use. He said that the fixing the fields should be a partnership between the City and the people who use it and offered that the kids will volunteer to pick up rocks or do what needs to be done to get the field in better condition.

Austin Castilleja asked City Council to help his team get a better field.

Renee Castilleja, 833 Stonemanor Bay, announced that he coaches for the Seguin Youth Football League and stated that he was born and raised in Seguin and used to play football at the Boys & Girls Club, A.J. Briesemeister, and played at and graduated from Seguin High School in 1984. He gave his condolences to Ms. Mendez for the loss of her daughter and said that Sonia was such a nice person. He opined that Austin Castilleja's team will continue to win little league and eventually will be playing in High School. He agreed that Manuel C. Castilla Park needs improvement.

Julian Leal, 849 Prexy Dr., also said that Manuel C. Castilla needs improvements, starting with the planting of oak trees 40' feet apart and the trees need irrigation installed.

Gordan Allen, 625 S. Milam, informed that he also owns the property located at 2805 E. IH-10. Recently, a tree located in the right-of-way fell onto his property and he is trying to identify the owner of the property that had the tree fall so that they can come and remove it from his property. He asked the City to help him identify the property owner because he has gotten conflicting information thus far.

Mayor Dodgen announced that the deadline to sign up to have a float in the Holiday parade is November 21st. To date, there are a little less than 100 entries submitted. She reminded that this Thursday is Third Thursday and stores downtown will stay open until 8 P.M. Additionally, Mayor Dodgen announced that the third annual Community Table event will be held Sunday, November 24th from 4-6 P.M. at the Seguin Coliseum.

Councilmember Biesenbach thanked Chris Rangel for being awesome and said that he appreciates what he has learned from Chris and what Chris and lleen do for the Community, especially for the West End. Biesenbach said that he felt privileged to have been invited to help at their clean-up events.

Councilmember Rangel announced that tonight was his last night on City Council and thanked the City for allowing him to be a part of it. He said that he now understands the way things work and that it takes time for things to happen. He thanked the citizens of District 4 for voting for him to represent them for the last eight years. He encouraged residents to reach out to City Council, to get involved and to be part of the solution not the problem. He gave his final thanks to his fellow councilmembers, staff, and former mayors with which he served.

6. Presentation

a. Recognition of outgoing City Council Members. - Donna Dodgen, Mayor

Mayor posthumously recognized Sonia Mendez for her time spent as a council woman for Seguin as well as for all the great things she has done for the community. Mayor Dodgen asked that Public Works Director John Donnelly present Sonia's mother and daughter with a token of appreciation from the City and announced that Sonia Mendez will be the marshal for the Holiday Parade this year. Mayor Dodgen declared that Sonia Mendez was a big part of the family and she always will be.

Public Works Director John Donnelly stated that Sonia Mendez was dedicated to our City and is a big part of the reason why the City is trending upward.

b. Presentation regarding Seguin's recent designation as a JustServe City. Steve Parker, City Manager

Indexes:

City Manager Steve Parker reminded that about a month ago Selina Medina presented the JustServce portal to City Council. He announced that Seguin has received its JustServe City designation and invited Mrs. Medina to present.

Selina Medina explained that JustServe core values are to serve locally, help build community and build people. The portal allows for an organization post things they need volunteers with as well as sign up to volunteer. Mrs. Medina invited Bishop Tim Byrd to speak. Mr. Byrd said that this portal isn't possible without the creation of accounts. Mrs. Medina added that 50 organizations in our area have already added projects. She stated that Seguin is the first city in Guadalupe County that has become a JustServe City and presented City Council with a plaque.

Director of Economic Development Josh Schneuker gave an overview of the Seguin Economic Development Corporation 2023-2024 Annual Report. The report highlighted the Corporations marketing and recruitment efforts and their business retention and expansion efforts, as well as their infrastructure projects. He informed that a more formal report will be made available by the end of the week.

Noise Study Presentation. - Mike McMann, Police Lieutenant

Indexes:

Chief Jason Brady stated that at the direction of City Council, the Police Department completed a noise study. He introduced Lieutenant Mike McCann to present the results.

Lt. McCann said that patrol officers collected the data by taking decibel readings every other Friday and Saturday night from March 1st through September 31st of this year at several different venues in Seguin. The noise ordinance allows noise in residential districts up to 85 decibels from 8a.m. to 10p.m. Monday through Friday and 8a.m. to 11p.m. on Friday and Saturdays. Any other time, decibel readings must be below 75 decibels. Non-residential property located within 100 feet of residential property must follow the same decibel requirements as residential property. For non-residential properties not located within 100 feet of residential property, 85 decibels are permitted at all times.

In addition, Lt. McCann also reported that Code Compliance received two noise complaints after the noise study ended. They were both made by the same resident against The Schoolyard. They took measurements both of those instances and found no violation. However, they received another complaint against The School Yard on October 26th at 8:57 P.M. Officers took two measurements that night that were in violation. The sound engineer was warned and citations will follow for any further violations.

Lt. McCann gave examples of decibel readings for common sources of noise. A ticking watch would have a decibel reading of 20, the noise from a food processor is 95 decibels, and a jackhammer is 130 decibels. Additionally, he added that he took a reading in council chambers prior to the meeting and the reading was 75 decibels.

Councilmember Gaytan shared that he lives on Nolte, can hear The Schoolyard from his residence, as is familiar with the activity there. He said it seens like the band stops at 10 P.M. but a disc jockey starts after 10 P.M. He asked why the officers took readings at 10 P.M. and KLt. McCann answered that the officers get busier as it gets later in the night. Councilmember Gaytan suggested that the Police Department take decibel readings before 10 P.M. while the bands are still playing, not once they move the a DJ. He said he didn't want to pick on The Schoolyard, but is concerned for the residents who live near there. McCann encouraged residents to call the Police Department if they have disturbances. He said the initial contact would be a warning followed by enforcement if the noise ordinance violation continues.

Finance Director Susan Caddell introduced Duane Westerman with SAMCO Capital Markets and Matthew Lee with Norton Rose Fulbright to present on the proposed \$40,500,000 bond issuance.

Mr. Westerman explained that certificates of obligation are used for funding capital improvements and are secured by the authority to levy a property tax. He stated that the City of Seguin has received a S&P credit rating of AA, indicating that it has a very strong capacity to meet its financial commitments. Mr. Westerman gave an overview of the bond issuance timeline, stating that City Council would be approving the notice of intention at this meeting, which will commence a 45 day notice period. The notice will

Water and Wastewater Director Timothy Howe explained that the City has contracted with Freese and

Nichols, Inc. (FNI) for many years for professional services related to on-call modeling of the water and

wastewater utility to evaluate new developments and the timing and sizing of infrastructure.

For FY25, FNI provided an updated professional services proposal to provide water and wastewater modeling. He explained that FNI may provide the services listed in this agreement in additional to any engineering services requested on an hourly billing rate basis. Mr. Howe requested approval for professional services under this agreement for fiscal year 2025 in an amount not to exceed \$100,000.00. Funds are provided for these professional services by the developer, through fees collected for water and wastewater modeling services.

Assistant Fire Chief Garrick Herbert explained that City Council approved the pre-order of a fire engine during FY25, with an expected delivery time of late FY26 or early FY27. The lead time for a new fire truck is between 800 days and five years. The amount budgeted for the fire engine was \$1,100,000. Due to unforeseen price increases, the contract price is \$1,236,794, for the purchase of a Spartan Pumper on a Metro Star Chassis, a 20% increase in price since the last order.

Economic Development Director Josh Schnueker explained that Maruichi Stainless Tube Texas Corporation manufactures stainless steel tubes. Samsung, one of their main customers, is experiencing unexpected delays, preventing Maruichi from ramping up production and meeting the benchmarks associated with job creation. This amendment to the performance agreement would require that Maruichi would employ at least 40 full-time positions with an annual payroll of at least \$1.8M by December 31, 2025 and that they would employ 106 full-time positions with a minimum payroll of \$4.77M by December 31, 2026. Those benchmark dates were both pushed back for a period of one year, from 12/31/24 and 12/31/25 respectively.

Mr. Schneuker reported that the Seguin Economic Development Corporation approved these amendments a their last meeting.

Director of Engineering and Capital Projects Melissa Reynolds reminded that the City was recently awarded the Safe Streets and Roads For All (SS4A) Grant through the US Department of Transportation. The plan was developed to provide a framework of innovative strategies and implementation actions intended to reduce transportation-related fatalities and serious injuries while supporting federal safety initiatives. That plan has been developed and the draft plan has been released. Mrs. Reynolds thanked her team that consisted of Kimley Horn, Ms. O'Connell and her safety buddy Zach. She said that the committee was very well represented, with both school districts, the Sheriff's Department, Police Department, Fire Department, and Guadalupe County, as well as people who are both physically and visually impaired participating on the committee. In addition, there were several public outreach events hosted. Mrs. Reynolds introduced Raul Orozco with Kimley Horn to present.

Mr. Orozco gave an overview of the six main components of the Comprehensive Safety Action Plan. He invited residents to visit the online dashboard to view the High Injury Network and Interactive Crash Map. Approving this resolution would adopt the Safe Streets and Roads For All Comprehensive Safety Action Plan as the guiding document to achieve the goal of 50% reduction in traffic deaths and serious injuries by 2035 and zero by 2050.

The Walnut Branch project will be constructed in two phases, with Phase 1 to be in construction before the end of the year. Three bids were received for the Walnut Branch GLO Phase 1 Drainage Project. The low bidder, D&S Concrete Contractors, successfully completed similar work in the past 5 years. They are the same contractor who rebuilt 8th street recently. After reference check, it is recommended that the Walnut Branch GLO Phase 1 Drainage Project be awarded to D&S Concrete Contractors, LLC in the amount of \$1,973,519.
